RESOLUTION RAISING PARKING RATES AT CITY-OWNED PARKING FACILITIES

Resolved

WHEREAS, the Traffic Engineer is authorized, effective immediately, to set the following rates for parking in City decks and lots.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS, AS FOLLOWS:

<u>Section 1</u>. <u>Jefferson Street Deck</u> - The monthly rate for 5 days per week shall be \$85.00; the monthly rate for 7 days per week shall be \$90.00; the monthly rate for reserved parking shall be \$1325.00 with council approval; the hourly rate shall be \$1.00 for each half-hour with a maximum of \$10.00 for, all day (6AM to 6 PM); Evenings/special events shall be \$10.00. (Flat Rate 6PM to 6AM). Residents within the central business district receive a \$10 discount on 7-day rates

MEL Lot - The monthly rate for 5 days per week shall be \$70.00; monthly rate for employees shall be \$27.00; the hourly rate shall be \$1.00 per each half-hour with a maximum of \$10.00 for all day; Evenings/special events shall remain at be \$10.00. Residents within the central business district receive a \$10 discount on 7-day rates

Niagara Parking Deck- The monthly rate for 5 days per week shall be \$85.00; the monthly rate for 7 days per week shall be \$90.00 the hourly rate shall be \$1.00 for each half-hour with a maximum of \$10.00 for, all day (6AM to 6 PM); Evenings/special events shall be \$10.00. (Flat Rate 6PM to 6AM). Residents within the central business district receive a \$10 discount on 7-day rates

Twin Towers Garage - The monthly rate for 5 days per week shall be \$85.00; the monthly rate for 7 days per week shall be \$90.00 the hourly rate shall be \$1.00 for each half-hour with a maximum of \$10.00 for, all day (6AM to 6 PM); Evenings/special events shall be \$10.00. (Flat Rate 6PM to 6AM). Residents within the central business district receive a \$10 discount on 7-day rates

Spalding Lot - The monthly rate shall be \$4247.00.

Niagara Alley – The monthly rate shall be \$53.00.

<u>Section 2.</u> This Resolution shall be in effect immediately; provided, however, that the monthly rates contained herein shall be effective *January* 1, 2023.
