Council Member Moore commented that this item came before the City Council on an annual basis for approval. She remarked on the efforts and expressed her appreciation for the Advisory Commission on Human Resources and the City's Senior Grants Coordinator Kathryn Murphy. She remarked on the need for more organizations to apply for employment training dollars, stating that the City received very few employment training requests.

At the conclusion of her comments, Council Member Moore moved to approve the funding recommendations from the Advisory Commission on Human Resources for the 2020 Community Development Block Grant Public Service Funding, in the amount of \$260,000.00; seconded by Council Member Jensen.

Council Member Jensen expressed her appreciation for adding domestic violence services to the grant.

Council Member Jensen said she would need to abstain from voting on this item due to a conflict of interest. She said her husband's client owned the business and had provided consulting.

Council Member Montelongo asked the City Council to deny the request for a Special Use stating that 2301 West Glen Avenue was not an appropriate location.

Council Member Montelongo moved to deny an Ordinance approving a Special Use in a Class C-1 (General Commercial) District for adult use cannabis dispensary for the property located at 2301 West Glen Avenue (Parcel Identification No. 14-19-255-012), Peoria, Illinois; seconded by Council Member Oyler.

Mayor Ardis reminded the City Council that the vote was not on whether to allow adult use cannabis sales in Peoria, but rather it was a vote to allow for a Special Use at the location identified. He said the Planning and Zoning Commission conducted a Public Hearing wherein a unanimous recommendation from the Commission was forwarded to the City Council to approve the Special Use. He said he spoke with the President of the Rolling Acres Neighborhood Association and one of the owners of the Lariat Club who both said they were in support of approving a Special Use. In light of those comments as stated, he said he encouraged the Council to vote against the motion to deny and to vote in favor of a motion to approve.

Council Member Montelongo said there had been numerous discussions about adult use cannabis in the City and how it would change Peoria. He said the Council previously adopted an Ordinance stating it would be allowable in the Warehouse District and Industrial Districts. He said it was also allowed under a Special Use. He said he received a number of comments from the Westwood Neighborhood Association, and he moved to grant Privilege of the Floor to those citizens who wished to address the Council on this matter.

Hearing no objection, Mayor Ardis granted Privilege of the Floor to those citizens who wished to address the City Council regarding the proposed Special Use.

Angela Bertucci, President of the Westwood Neighborhood Association, expressed her concerns about allowing a Special Use at the location identified, noting the potential negative impact it could have on the neighborhood. She commented on the proximity of Concordia Grade School, Northwoods Mall and the neighborhoods. She asked the City Council to refrain from approving this location but to allow the location on University Street.

<u>Pam Doloszck</u>, a concerned citizen, stated that the traffic at the proposed location was already an issue, and she said opening an adult use cannabis facility would contribute to the traffic congestion. She commented on the potential for increased foot traffic that would gravitate to the nearby neighborhood with increased crime.

Mark Walton, a Peoria-based attorney for Trinity Compassionate Care, remarked on the facility's security requirements, noting the existing Trinity on University already had 30 cameras and would be adding 20 additional cameras. He said it was the intent of the business owner to install in excess of 40 cameras at the Glen Avenue location. He said concerns about crime or the issue of it being a gateway drug were addressed by the State Legislators, noting the strict regulations.

Motion to DENY an Ordinance approving a Special Use in a Class C-1 (General Commercial) District for adult use cannabis dispensary for the property located at 2301 West Glen Avenue (Parcel Identification No. 14-19-255-012), Peoria, Illinois, was DEFEATED by roll call vote.

A revised Council Communication changing the proposed Ordinance to a proposed Resolution, accompanied with a Resolution, and Planning and Zoning Commission minutes from December 15, 2019, were distributed to all Council Members.

Council Member Moore provided an overview of the proposed Resolution commenting on the efforts of City Planner Kimberly Smith, IDG+ Architects and the PCCEO along with a number of other stakeholders involved in developing a plan for the MacArthur Corridor, Southern Gateway and Western Avenue. She reviewed the South Village Revitalization Plan highlighting the proposed Community Air Market and the Workforce Training Center. She said the purpose of the Plan was to show the City was behind the development of the Southside and the MacArthur Highway Corridor. She said the Plan set forth an implementation schedule that would incentivize private investors and would provide more leverage in obtaining grants from the Federal and State levels. She said the Comprehensive Plan was available on the City's website, and she expressed her appreciation to City Planner Smith for her efforts on amending the City's Comprehensive Plan.

Council Member Moore moved to approve a Resolution amending the Comprehensive Plan to include the South Village Implementation Plan featuring the MacArthur Corridor Plan, MacArthur

Plan, Southern Gateway Plan and Western Avenue Plan; seconded by Council Member Ali. Council Member Ali said she enthusiastically supported the proposed amendment to the Comprehensive Plan. She remarked on the public meetings held and the tremendous interest generated from the community. She said this item provided a lot of hope to community leaders, and she commended City Staff and the citizens who played a part in developing the proposed plan. She said it provided potential to attract private investment and put the City in an area of growth for the Southside. She said this was an opportunity to grow population, businesses, organizations and increase hope. She said she was honored to second the motion to approve the Resolution and to support the revisions to the City's Comprehensive Plan.

PRESENTATION

(19-393) Communication from the Chief Diversity and Inclusion Officer, Human Resource Director and City Manager with a PRESENTATION on the CITY'S WORKFORCE COMPOSITION AND DIVERSITY GOALS.

City Manager Urich provided a presentation on the City's Workforce Composition and Diversity Goals. He reviewed the City's population statistics as of 2010, and the male and female minority data from the 2009 EEO Report. He reviewed the City's reduction in staff since 2009 noting a reduction from 812 in 2009 to 631 in 2019, for a total of 22%. He reviewed the male and female minority data from the 2019 EEO Report and reported on the total number of white employees compared to minority employees from 2009 through 2019. He reviewed the workforce and the job categories and compared the diversity from 2009 to 2019. He reviewed the City's long-standing hiring strategies and its plans for 2020.

Council Member Jensen expressed a concern about the recruitment efforts and the decline of female recruits. She said part of the plan needed to obtain more women and minorities in leadership positions. She said she applauded the efforts of staff and Council who had diversity as a priority. She remarked on the need for more regular reports and discussions and on the importance of having a diverse workforce.

Council Member Ali said the Affirmative Action Plan should not only focus on women and minorities, but should include veterans and individuals with disabilities as well. She said the City needed to continue to track these numbers and the number of applications received and the number of jobs offered.

Council Member Ali moved to receive and file a presentation on the City's Workforce Composition and Diversity Goals; seconded by Council Member Cyr.

FIRST READINGS

(19-394) Communication from the City Manager and the Chief of Police with a Request for a FIRST READING Review of an ORDINANCE Amending Article V, Section 30 of the CODE of the City of Peoria Relating to TOWING OF PRIVATE VEHICLES - DUTIES AND REQUIREMENTS OF TOW OPERATORS ON LIST.

Police Chief Loren Marion provided an overview of the proposed revisions to the City's current Tow Ordinance, noting the last revision was made in 2011. He said Detective Brian Terry obtained a list of comparables and he said the proposed Ordinance was consistent with Illinois law. He said the proposed annual fee for tow companies would compensate the City for inspections.

Council Member Moore moved to grant Privilege of the Floor to those individuals who wished to speak on this item.

Hearing no objection, Mayor Ardis granted Privilege of the Floor to those who wished to speak on the issue.

Don Stanton, owner and operator of a towing company in the City for the last 31 years, spoke on the proposed amendments to the Ordinance. He said the City granted two raises to the tow companies during his tenure. He said he had reached out to the Police Department and to various Council Members to provide his input on the proposed fees. He expressed concern about the \$250.00 fee imposed on towing companies, stating that those fees would make the raises moot. He said there were no other municipalities within 150 miles that implemented such fees, stating that Peoria would be setting a precedence with surrounding communities. He remarked on the verbiage used in the proposed Ordinance noting the issues as proposed. He said Peoria had the lowest towing fees compared to other communities. He remarked on the issues of owning a towing company and the number of cars that were not claimed by their owners. He said he continued to pay his employees regardless of whether the towed vehicles were claimed. He said all the abandoned vehicles, boats and campers were costly for him to dispose.

Bruce Pedigo, owner and operator of a towing company in the City, said he belonged to various State and national towing organizations. He said the initial efforts in providing increases to the towing companies were positive, noting that the City had been lagging behind other communities on the rates. He reviewed the proposed Ordinance noting there were several clerical issues that needed to be addressed. He commented that the language in the State Statute should be adopted in the Ordinance. He said he had reached out to the City Manager's Office to offer his input on the process; however, he said the City Manager's Office had declined. He asked to be involved in the drafting of the Ordinance prior to its adoption by the City Council.

Mayor Ardis recommended contacting the various tow companies to obtain input prior to the Ordinance coming back to the City Council for a second reading.

Discussions were held regarding the proposed fee, and Corporation Counsel Don Leist said the fee would cover the cost of City inspections, which would compensate for the City's time and expense.

Council Member Ali moved to receive and file the First Reading review of an Ordinance amending Article V, Section 30 of the Code of the City of Peoria relating to towing of private vehicles – duties and requirements of tow operators on list; seconded by Council Member Cyr.

Snow and Ice Plan Update

Council Member Grayeb inquired whether there was additional information relating to the City's Snow and Ice Plan. Public Works Director Rick Powers said there had been an added route on the north side of the City, which was previously discussed in a presentation provided by Assistant Public Works Director Sie Maroon. He said the City also added another piece of equipment that would allow for brining the streets more often, which would be more cost effective. He said it was their intent to brine in neighborhoods pre-storm where rain was not anticipated. He said the brine would melt the snow reducing the number of times the Public Works Department would have to clear snow in neighborhoods.

NEW BUSINESS

Report Back Regarding Communication Efforts Using the Public Access Channel
Communications Specialist Stacy Peterson provided an overview on efforts to utilize the City's
Public Access Channel. She said the City recently purchased a software program called
Tightrope, a digital signage program seen in hotel rooms, that provided the opportunity to list
meetings, stream urgent information, and post meeting notices. She said there had been some
technical difficulties initially, but she said they were able to work past those and were now

learning how to use the software. She said the City was still on track to launch the program on January 1, 2020. She said she would be meeting with the Program Director from Champaign, Illinois, noting Champaign had a robust Public Access Channel, if not many, and was using the same software. She recommended training Staff in the Information Systems Department as backup in order to have all bases covered.

Council Member Moore expressed her appreciation, remarking on the importance of utilizing the PAC to reach out to the community. She remarked on the City's efforts utilizing social media; however, she said there were many citizens who did not use social media or a computer.

Recognition of Commonplace and Neighborhood House

Council Member Moore expressed her appreciation to Pamela Rumba, Executive Director of Common Place, the staff and Board of Directors for the impact they made on the community. She said Neighborhood House would pick up the programming from Commonplace once they had closed. She said all the services would continue to be offered, but would be offered at Neighborhood House. She said it was her hope that those individuals who donated their time at Commonplace would continue to donate their time at Neighborhood House.

City-Owned Properties on MacArthur and Western

Council Member Moore commented on a number of positive developments that had occurred on the North Side, North Valley, South Side and South End during 2019. She highlighted notable developments such as Greeley School, Ronald McDonald House, Women's Club and the Armory, most of which would not have happened had it not been for private and City support. She said she asked Assistant City Manager Deborah Roethler to review vacant City properties on Western and MacArthur and to issue Requests for Inquiries to see who would be interested in those parcels to develop according to the near revised Comprehensive Plan. She asked that once that information was available it be posted to the City's website.

22VA Exhibit - December 7, 2019 - January 30, 2020

Mayor Ardis invited everyone to attend the 22VA Exhibit on display at the Peoria Public Library – Lower Level 1 from Saturday, December 7, 2019, through Thursday, January 30, 2019 from 1:00 P.M. to 3:00 P.M. He said the art displayed was from veterans who used art to express emotions and feelings that were brought back after serving the Country. He said there was additional information on the City's website at http://www.peoriagov.org/22va-veteran-art-exhibit-opens-at-the-peoria-public-library-main-library/.

Recognition of H. Wayne Wilson

Mayor Ardis announced that tonight was the last meeting H. Wayne Wilson from WCBU would be covering the City Council meeting, noting his 50-years of being in the business. He said H. Wayne Wilson was a respected member of the media and would be greatly missed and he congratulated him on his next endeavor.

CITIZENS' OPPORTUNITY TO ADDRESS THE CITY COUNCIL/TOWN BOARD

Hearing no objection, Mayor Ardis granted Privilege of the Floor to those citizens wishing to address the City Council/Town Board.

<u>Lavetta Ricca</u>, a citizen of Peoria, expressed her appreciation to City Staff who built her a wheelchair ramp. She said due to her income status she had qualified to receive assistance from the City to build the ramp and she remarked on the efforts of Staff and the quality of the ramp. She wished everyone a Merry Christmas and a Happy New Year.

Mayor Ardis expressed his appreciation to Ms. Ricca and her lifelong devotion to the community.

Noemi Medina, a citizen of Peoria and member of the Light of the World Church, said it was the Church's mission to reflect its name in the community and to make an impact. She said in the future they would like to establish hope fairs and APS (Association of Professional Studies) programs that would be free to the public. She said APS was a national not-for-profit organization that promoted higher education to disadvantaged students. She invited the Council to a concert on December 14, 2019, at 200 NW Water Street, Peoria, stating it would be a celebration of the Church's apostolic leader with the purpose of familiarizing the community the Light of the World Church.

Michael Chavez, a citizen of Peoria and member of the Light of the World Church, reviewed the mission of the Church stating it was a nationwide goal. He said their message was of spiritual salvation without discrimination. He reviewed their mission and said it was their goal to bring that mission to the City of Peoria.
