EXTENSION OF ACQUISITION CONTINGENCY UNDER THE FIRST AMENDMENT TO ANNEXATION AGREEMENT

THIS EXTENSION OF ACQUISITION CONTINGENCY UNDER THE FIRST AMENDMENT TO ANNEXATION AGREEMENT (FOR PARCEL 4) (the "Extension") is made and entered into as of the 27 day of August, 2014, by and among the CITY OF PEORIA, an Illinois municipal corporation, located in Peoria County, State of Illinois ("City"), by and through its Mayor and the Members of its City Council (hereinafter sometimes referred to collectively as the "Corporate Authorities"); JAMES S. CHAMBERS, THOMAS J. CHAMBERS, and TERRY L. CHAMBERS (hereinafter collectively referred to as the "Chambers"); TWENTY FOUR CORP, LLC, an Illinois limited liability company ("TFC"), PETERSEN COMPANIES, LLC, an Illinois limited liability company ("Petersen Companies"); and PETERSEN HOSPITALITY, LLC, a Delaware limited liability company, ("Petersen Hospitality")

RECITALS:

WHEREAS, On April 24, 2014, the Parties executed a First Amendment to Annexation Agreement with regard to the annexation of the property described in the attached Exhibit A (the "Property"); and

WHEREAS, the terms of the First Annexation Agreement provided that the Agreement shall be null and void if TFC failed to acquire the Property from the Chambers on or before June 30, 2014, unless such date is extended in writing by the parties thereto; and

WHEREAS, TFC now seeks an extension of the acquisition deadline set forth in the Agreement from the other parties hereto until July 31, 2014; and

WHEREAS, a public hearing regarding the Extension was held before the City of Peoria Planning and Zoning Commission on August 7, 2014, in accordance with Section 11-15.1-3 of the Illinois Municipal Code.


