

**ORDINANCE 17,397**

**AN ORDINANCE AMENDING THE CITY OF PEORIA 2016/2017 BIENNIAL BUDGET  
RELATING TO THE HOME AND CAPITAL FUND BUDGET FOR FISCAL YEAR 2016 TO  
REFLECT THE ACTUAL 2016 ALLOCATION FROM THE UNITED STATES HOUSING AND  
URBAN DEVELOPMENT (HUD) AND THE TRANSFER OF CDBG PROGRAM INCOME TO  
THE CAPITAL FUND**

WHEREAS, the City Council did adopt, on December 8, 2015, the 2016/2017 Biennial Budget for the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2016/2017 Biennial Budget should be amended in order to add certain expenditures that were not included in said 2016/2017 Biennial Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:

Section 1. The 2016/2017 Biennial Budget of the City of Peoria is amended by adding the following expenditures and revenues in the designated funds:




Section 2. This ordinance shall be in full force and effect from and after its passage and approval according to law.
