AN ORDINANCE AMENDING THE CITY OF PEORIA 2016/2017 BIENNIAL BUDGET
RELATING TO THE HOME AND CAPITAL FUND BUDGET FOR FISCAL YEAR 2016 TO
REFLECT THE ACTUAL 2016 ALLOCATION FROM THE UNITED STATES HOUSING AND
URBAN DEVELOPMENT (HUD) AND THE TRANSFER OF CDBG PROGRAM INCOME TO
THE CAPITAL FUND
