In discussion with Chairman Pro Tem Miller, Ms. Lutes said they wanted to have an upscale neighborhood bar. She said they wanted to keep it clean and comfortable for all the people who work and visit the downtown area.

In discussion with Commissioner O'Brien, Ms. Lutes said initially they did not plan to be open for lunch, but she said they were looking to have a happy hour period opening up around 3:00 or 4:00 p.m. in the afternoon. Ms. Potter said they had to unfortunately limit their menu items because of the current size of their kitchen.

In response to Commissioner Coates question of when they planned to open, Ms. Potter said they would be doing very little remodeling and she said they wanted to open for business as soon as possible.

In more discussion, Building Inspector Stevens said if the applicants decided to remove a wall, they would have to submit something to the Building Department for review. Ms. Potter submitted copies of their floor plan for the Commission and Staff to review.

Hearing no further questions, Chairman Pro Tem Miller called for the motion.

Commissioner O'Brien moved to recommend approval of the Site Application for a Class A (tavern) Liquor License, with a Subclass 1A (2:00 a.m. hours) and a Subclass 2 (live entertainment) for 456 Fulton, Suite 105; seconded by Commissioner Coates.

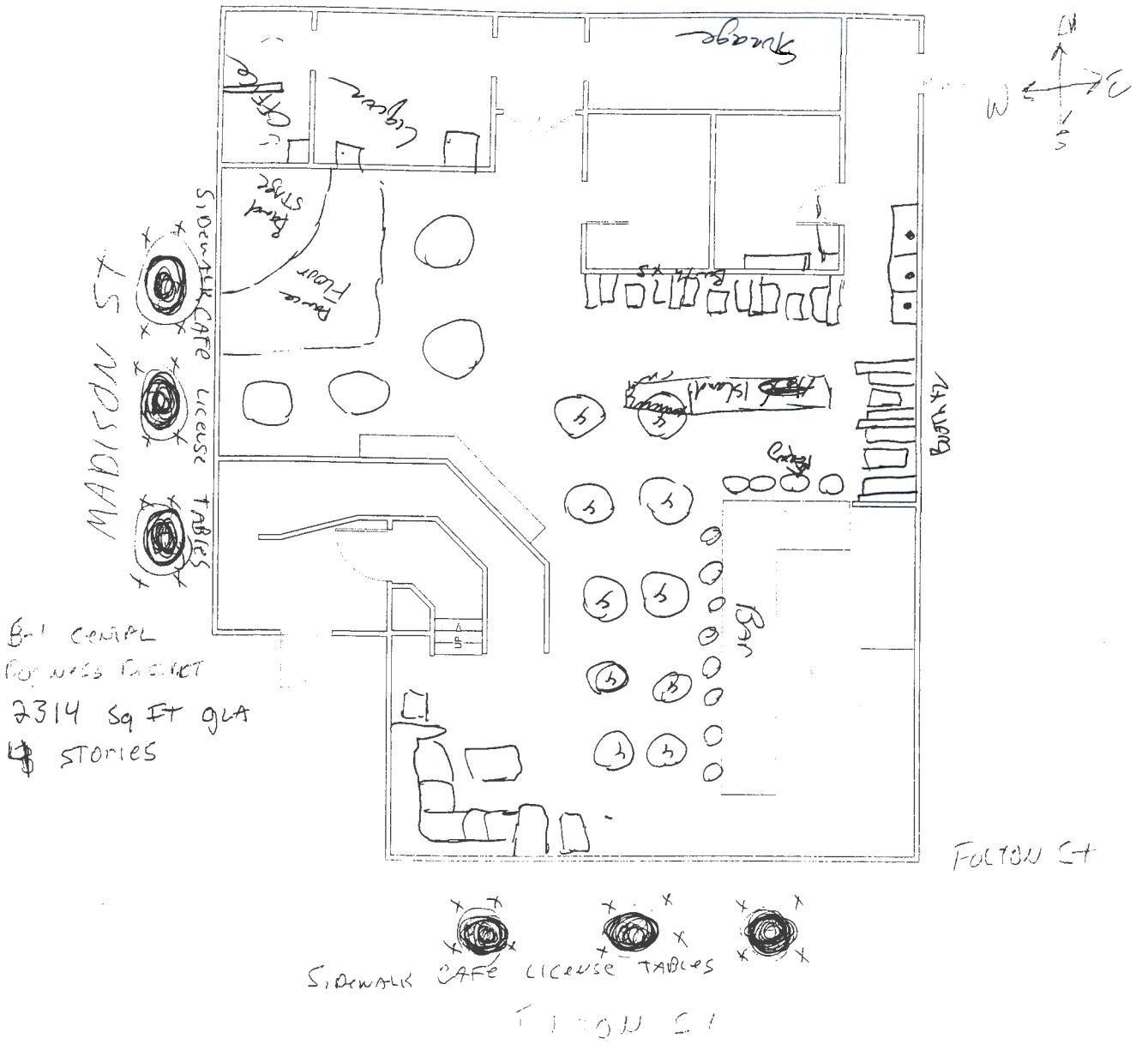

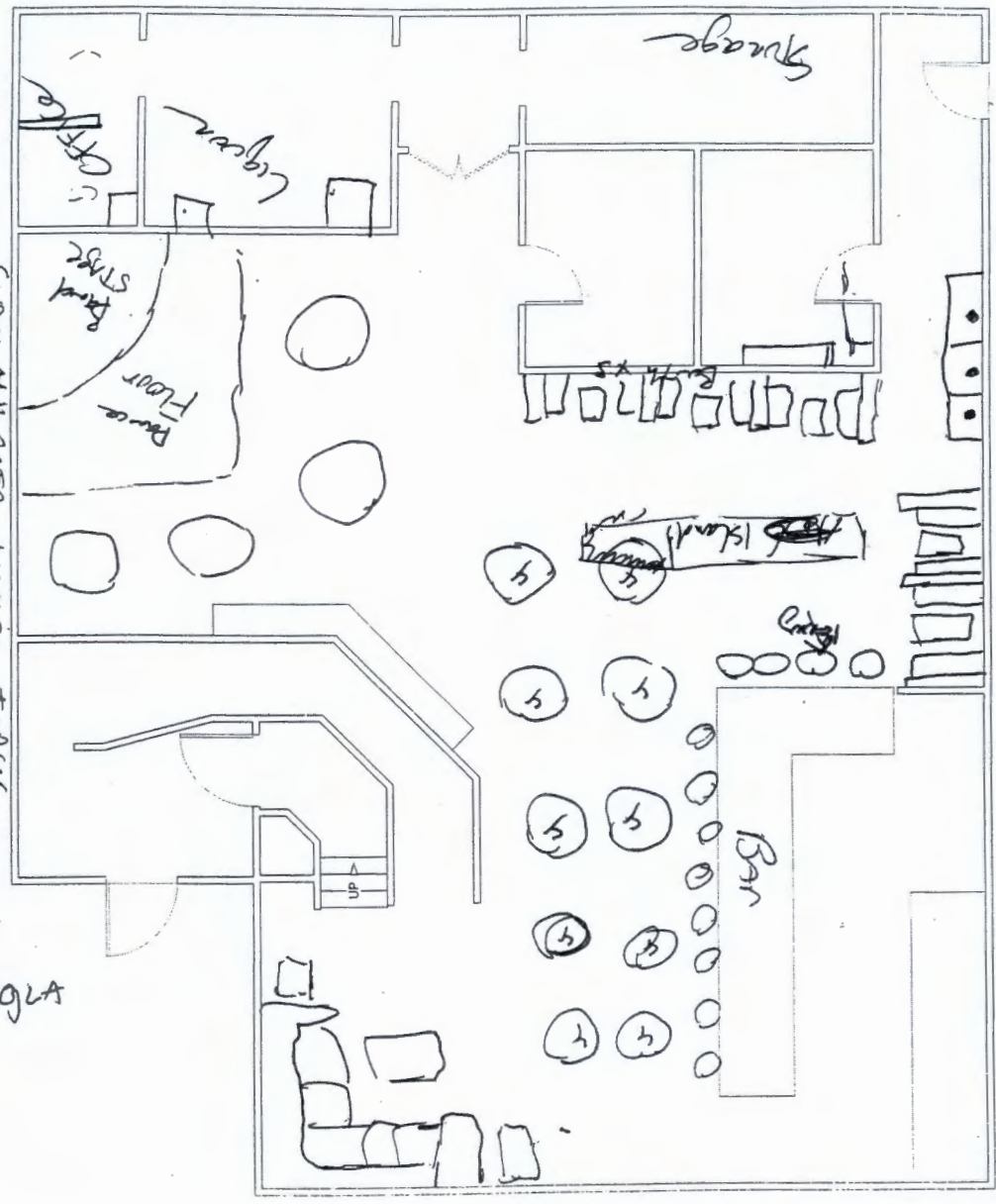
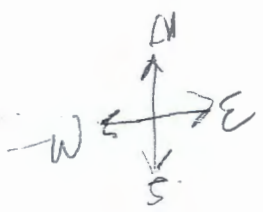

A site application has been received from JSS, Inc., d/b/a Kickback on Fulton, 456 Fulton, Suite 105, Peoria, Illinois, for a Class A, Subclass 1A and Subclass 2 liquor license. The approval of this request will allow the applicant to operate a tavern with 2:00 closing hours and live entertainment. This location previously operated as the Black Rabbit restaurant and held a B-1 liquor license with live entertainment.

This location is part of the twin towers complex. The twin towers, while containing condominiums, is not zoned residential. The proposed tavern is on the first floor of the towers in the southwest corner and there is a separate entrance and exit. Officer Jordan inspected the location and found it to be approximately 102 feet from Sacred Heart Church. This is outside the distance which would prohibit a tavern from being approved at this location. Officer Jordan also checked Peoria Police incident reports and found no reports of trouble or disturbances at this location when it operated as the Black Rabbit.

It appears that this request is appropriate for this location and would not be detrimental to the surrounding businesses or the residents of the complex. There are no parking or traffic concerns raised by this request.

The Peoria Police Department has no objections to this site approval request.
