Introduction

Please complete this letter and **submit to Kate Green, HOIHCOC Director, no later than 5pm, September 20, 2019.** Letters and agency HMIS data will be reviewed by the HOIHCOC Governing Board, and a funding recommendation will be provided by the Board to the Peoria City Council. HOIHCOC recommendation does not guarantee agency funding. Board-recommended agencies must fill out a program application that will be returned to the Continuum and submitted to the City as part of a Continuum-wide application package for ESG funds. Final authority regarding the funding award rests with the Peoria City Council.

Note: Should the agency be awarded ESG funds this goal will be monitored on a quarterly basis. For emergency shelter programs, this number will be tracked via ESG CAPER question 23a Exit Destinations – All Persons; Permanent Destinations. For Rapid Rehousing Programs, it will be tracked by individuals moving into permanent units supported by RRH funds as part of the program. This should be the definition of clients served under HMIS reporting for ESG Rapid Rehousing Program.
