ORDINANCE NO. TO-20- 03

AN ORDINANCE LEVYING AND ASSESSING TAXES FOR THE FISCAL YEAR BEGINNING APRIL 1, 2020 AND ENDING MARCH 31, 2021, OF THE TOWN OF THE CITY OF PEORIA, PEORIA COUNTY AND STATE OF ILLINOIS FOR THE TOWN GENERAL FUND AND ILLINOIS MUNICIPAL RETIREMENT FUND

BE IT ORDAINED BY THE BOARD OF TOWN TRUSTEES OF THE TOWN OF THE CITY OF PEORIA, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

<u>SECTION 1.</u> That the total amount of appropriations for Town General Fund and Illinois Municipal Retirement Fund purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of Five Hundred Seventy Thousand Six Hundred Twelve Dollars and No/100 (\$570,612).

SECTION 2. That the sum **Five Hundred Seventy Thousand Six Hundred Twelve Dollars and No/100 (\$570,612)** being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the Town of the City of Peoria for the purposes of providing for a General Town Fund, and Illinois Municipal Retirement Fund, as appropriated for the current fiscal year by annual appropriation ordinance of the Town of the City of Peoria for the fiscal year 2020-2021 passed by the Board of Trustees of said Town at the legally convened meeting of June 23, 2020, be and the same is hereby levied upon all the taxable property in the Town of the City of Peoria subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein by being placed in separate columns under the heading "TO BE RAISED BY TAX LEVY" which appears over the same, the tax levied being for the current fiscal year of said Town, and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:

<u>SECTION 3.</u> That the total amount of <u>Five Hundred Seventy Thousand Six Hundred Twelve Dollars and No/00 (\$570,612)</u> ascertained as aforesaid, be, and the same is hereby levied and assessed on all property subject to taxation within the Town of the City of Peoria according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.

SECTION 4. That there is hereby certified to the County Clerk of Peoria County, Illinois, the several sums aforesaid, constituting said total amount and which said total amount Five Hundred Seventy Thousand Six Hundred Twelve Dollars and No/00 (\$570,612). The said Town of the City of Peoria requires to be raised by taxation for the current fiscal year to meet and defray the necessary expenses and liabilities for the Town General Fund and Illinois Municipal Retirement Fund of the Town, and the Town Clerk is hereby ordered and directed to file with the County Clerk on or before the time required by law, a certified copy of this ordinance.

<u>SECTION 5.</u> That this ordinance is in addition to <u>Ordinance No. TO-20- 03</u> adopted by the Board of Town Trustees of the Town of the City of Peoria on <u>DECEMBER</u> <u>08</u>, 2020 levying taxes in the amount of \$715,971 for the General Assistance Fund for the fiscal year beginning April 1, 2020 and ending March 31, 2021.

SECTION 6. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
