

**ORDINANCE 17,680**

**AN ORDINANCE AMENDING THE CITY OF PEORIA 2019 REVISED BUDGET RELATING TO THE USE OF SOUTH VILLAGE TIF FUND BALANCE IN THE AMOUNT OF \$35,000 AND THE USE OF THE EAGLE VIEW TIF FUND BALANCE IN THE AMOUNT OF \$15,000 TO PROVIDE FUNDING FOR STUDIES, SURVEYS, PLANS, AND PROFESSIONAL SERVICES.**

WHEREAS, the City Council did adopt, on December 4, 2018, the 2019 Revised Budget for the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2019 Revised Budget should be amended in order to add certain expenditures that were not included in said 2019 Revised Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:

Section 1. The 2019 Revised Budget of the City of Peoria is amended by adding the following expenditures and revenues in the designated funds:
