Bryan Harlan, Owner, Tannins & Hops, presented a Site Application for a Class B-1 (restaurant, 25% food) Liquor License, with a Subclass 1A (2:00 a.m. closing hours), a Subclass 2 (live entertainment), and a Subclass 3 (beer garden) at 619A SW Water.

In discussion with Chairman Cassidy, Mr. Harlan said he did not plan to be open until 2:00 a.m., but he said he was only seeking the Subclass 1A (2:00 a.m. closing hours) in order to have that option available. He went on to say that if they had a good crowd, he wanted to be able to remain open longer.

During more discussion, Mr. Harlan reported that his business was located in Rhodell's old establishment. In regards to the beer garden, he clarified on the diagram that it would not be located along the sidewalk on State Street. He explained that it would be located next to his establishment between the buildings, inside of the railing.

In more discussion, Mr. Harlan said his goal was to be open by Thanksgiving.

In response to Commissioner Miller's question about the platform area in front of the building, Mr. Harlan said he did not plan to use the outdoor area for any live music. He said live entertainment would be located inside of the establishment only. He said his business would be a speakeasy and he said he did not want to draw any attention.

Senior Urban Planner Kimberly Smith reported there weren't any issues as far as the Zoning, because they did not consider the request to be a change of use. However, she said she wanted to make sure the applicant obtained all of the required building permits.

Hearing no more questions, Chairman Cassidy called for the motion.

Commissioner O'Brien moved to recommend approval of the Site Application for a Class B-1 (restaurant) Liquor License, with a Subclass 1A (2:00 a.m. closing hours), a Subclass 2 (live entertainment), and a Subclass 3 (beer garden) at 619A SW Water, contingent upon the successful compliance with all the final building inspections; seconded by Commissioner Kelsey.

Tannins & Hops Business Plan

Background

I graduated from Illinois State University with a Marketing Major and Minor in Speech Communications. I've worked in the sales area for all of my adult life, from selling outdoor advertising, to working in an advertising agency, to selling beer. I've been in the bar industry for the past 11 years working closely with owners, bar managers, general managers, as well as customers from all varying paths of life.

I have worked in the Peoria market since 1998 and I know what this town likes, doesn't like...needs and doesn't need....and what works and doesn't work. I don't know how many times a new bar/restaurant will open up and I know it will be gone in 6 months or less. I've seen it too many times. Because of that, I know my concept will not only work in Peoria, but will be extremely successful as well.

Executive Summary

Tannins & Hops will be a speakeasy/lounge concept, with its focus being on wine and craft beer. It will serve a limited menu, with its main focus on cheese and charcuterie boards. Tannins (compounds occurring in wine and imparting an astringent taste) and Hops (flowers used for flavoring and aroma in beer) are common speak in both the wine and beer worlds. I want to impart the knowledge that our staff would have when speaking with our customers simply by the words chosen to represent the business.

The location of the bar is key....as they always say, "location, location, location". Well, the bar is located right around the corner from Cat's world HQ, near the Peoria County Courthouse, near several law firms, banks, 4 blocks away from 3 hotels that have over 500 hotel rooms total, and 4 blocks away from the Peoria Civic Center. There are currently 12-15 other bars within a ¼ mile radius, NONE with this type of theme. The location I'm currently looking into has been in operation for 16 years, and the previous owners are moving into a larger location down the road.

With the climate of the bar industry changing all the time, and the laws affecting drivers changing all the time, the bar itself needs to make sure that it stays current with the trends...to a certain extent. The philosophy behind the bar will be as follows:

- -To be a place where professionals can go to meet with clients
- -Craft beer geeks can go to have some of the best brews in town in the nicest atmosphere
- -Women can go to either drink beer or some fantastic wine
- -A quieter atmosphere with limited TV's in the main bar area, and softer, yet classy music playing in the background
- -An off-premise license to go along with the on-premise license because there aren't any places in downtown Peoria for travelers to buy beer/wine
- -An ever changing/evolving menu catering to artisanal cheeses and meats

-A menu that will give you suggestions on what to eat with what you're drinking

I feel that if I stay true to the above philosophies, I will have a bar in Peoria that is on the cutting edge of drinking establishments.

Mission Statement

Why do the same thing everyone else is doing when you can be unique? That's what Tannins & Hops will be in the Peoria area. There is NO place like the one I have planned here. I want to not only be a staple for the local residents, but a place that all the travelers HAVE to visit, similar to The Safehouse in Milwaukee. It's a "must visit" by a lot of the travelers whenever they visit that city. With all the Irish bars, sports bars, music venues, college bars and dance clubs in the area, there is a need to have a place different than all the rest.

Market Analysis

There are roughly 450 bars/restaurants/taverns/etc in the Peoria Tri County area. As far as downtown Peoria, there are roughly 20 such establishments in about a one-mile radius. None of them are even remotely close to what we're trying to do here. You have your Irish, Dance/College, Music Venues, Chain restaurants, and Strip Clubs...none with an atmosphere like the one I propose to have. Downtown Peoria is in a transitional phase at this time....2 new rebuilt hotels with one in progress, a newer development area near the riverfront that is bringing new business downtown, and a Civic Center that is continuing to build it's concert and conference business. Not to mention, Caterpillar just showed their plans for their expansion starting in 2016 which will change the skyline of Peoria forever. I project that within 5-10 years, downtown Peoria will be booming once again.

Marketing

With today's social media pretty much dominating a great deal of advertising, we would start there. Along with that, a constantly updated website to drive traffic through the doors will be a must. I also plan on meeting with managers of the hotels around downtown and setting up some sort of a program with them for when out of town travelers ask where to go, we are the first one they mention. Finally, I'd make sure to use my contacts having been in the industry for the past 11 years to help build a database of people to email. By being a speakeasy, our entrance would be somewhat hidden, which would garner a lot of attention by word of mouth. "Just look for the green light" is what people will be saying.

About the Location

The location is roughly 3000 sq ft and already has a lot of the qualities of a speakeasy with the 100 year old wood floors and brick interior. The entrance to the bar will be moved from up front and center to the left corner (looking at the building from the outside) and will be noted by a green light above the door. When the light is lit, we're open...when it's not, we're not.

There will be a decent amount of renovation being done to the current infrastructure. First, the bathrooms will need to be moved and redone to meet the standards that I'm looking for. By moving them back 5-7 feet, it will open the location up even more. Second, the current location of the bar will need to be torn down and rebuilt in another location. By moving the bar, we can add an additional 20

people around it instead of the current 7! Finally, we will be removing some walls to open up about an additional 750 sq ft. We will also have a small storefront that people will have to walk through in order to enter and leave the bar, which will add additional revenue with beer/wine sales as well as merchandise sales.

As far as other décor on the walls, I want to keep it simple. I see open curtains throughout to give it a softer feel to go along with historic old photos of downtown Peoria from the past. I also see photos from our famous people that have come from Peoria. Sconces throughout the place to give it a warm, comfortable feel also.

The bar will be a long wood bar facing the beer cooler and hanging tap handles. There will also be a smaller, communal bar located within the bar itself. Along with that, we will have 4-5 high tops seating 4 people each. The high tops will be made out of old wine barrels. In the back of the bar will be our dining area with 8-10 low tops. Where the old brewery used to be, that will be the location of the lounge with leather chairs and coffee tables.

Hours

The hours of the bar will be:

Tuesday-Thursday 4 PM -11 PM

Friday-Saturday 4 PM - 12 AM

Closed Sunday and Monday, unless there is a concert or other convention going on.

Products

There are 14 tap handles, all of which would be either craft or imports. No domestics would be on tap or in bottles at all. I would carry no more than 40 different beers and wines at any given time. The beers on tap would change practically daily, while the wines wouldn't vary as often. We would have at least 20 different cheeses that would pair with every single thing we carry, as well as be used to serve with the sandwiches.

We will also be investing in a cruvinex system in order to serve wine flights straight from the bottle. I'm looking at either a 12 or 24 bottle cruvinex system to house a range of wines.

Beer

We would carry everything craft and imports ranging from Pilsner styles to Pale Ales to IPA's to Barleywines to Russian Imperial Stouts. We would carry several different styles of glassware to go along with the respective beer. For example, we would have an IPA glass for most of our IPA's and snifters for our higher alcohol brews. The bottle selection would probably change monthly, while maintaining about 10-15 staple brews which we'll carry all the time. The drafts would cover the spectrum of styles out there and change weekly, if not daily.

Wine

We would carry everything in the range of white to rose to red to champagne. If it pairs well with our food and cheese selections, anything would be considered. We would have price ranges similar to a

bar with well, call, and top shelf liquors. We would have a separate large stemmed glass for whites, reds, rose's and flutes for champagne.

Liquor

We will have a limited hard alcohol menu, meaning we probably won't have more than one type of tequila, one type of vodka, etc. I'd like to have about 10 signature cocktails named after 10 different historic/famous people that have come from the Peoria area.

Menu

It would be a limited menu that would change roughly every month. We would always carry a meat/cheese plate, a fruit/cheese plate, and a cheese only plate. We'd also serve upscale grilled cheese sandwiches (they came about during the 30's which fits our theme) that will leave your palate begging for more. I'd like to keep the menu options to no more than 15 or so items at any given time.

As far as the meats and cheeses, we would carry products from around the world. Some, if not most, that people in Peoria have probably never heard of let alone had. That will also be a draw in my opinion.

The Staff

The front of the house staff would be dressed in black slacks, white button up shirts, and black vests (both men and women). They will be well versed in the beers/wines that we carry as well as the food we serve. We will have meetings with staff before any convention downtown or any concert as well to verse them on the type of clientele that will be coming in to town.

The back of the house can wear anything they want, unless they're a cook/chef. Then, they will wear chef jackets and also be asked to interact with the customers at any given time.

Summary

I'm looking to help grow the downtown Peoria nightlife, which has seen a dramatic decrease over the past several years. I want to be an integral part in the rebirth of downtown. I want to work with other local establishments, and not against them. There is plenty of business to go around, I merely want to give that consumer another option to choose from. Hopefully, I can help the decision on "where to go" is directed back to downtown.

This is a business that fluctuates like the stock market, but at the same time, has been around for hundreds of years. Alcohol is not going away, food is not going away...just how you provide these services depends upon the success of the individuals involved. And, this model will not fail.


