If business tenant plans to complete the improvements, property owner's consent must be shown in writing –Form B3 or B4);
- 6. Copy of written contract(s) with contractor(s), if applicable;
- 7. Construction plans with material, schedule and dimensions;
- 8. Site plan with elevations, showing improvements drawn to scale;
- 9. Final architect cost estimates, if applicable;
- 10. Landscape and/or Signage plans, if applicable

The City of Peoria and its Community Development Department expressly reserves the right to reject any or all applicants or to request more information from any and/or all applicants in its sole and exclusive discretion. In addition, the City of Peoria reserves the right to cancel the program at any time, prior to grant approval and without notice, if sufficient funds are determined unavailable by the City of Peoria in its sole and exclusive discretion.



I propose to paint a mural to redesign a wall at 432 South Western Avenue, Peoria Illinois. The final mural will follow the design pictured below.

Design Description

The piece is currently untitled, it was originally derived from a previous drawing entitled *CONCRETE ROSES*, and it shares many of the themes of the original conception. In addition to the original concept, Adinkra symbols have been incorporated into the pattern laden design along with representations of some of our community's most successful young African Americans. (Pending their consent of course) The final mural will be rendered primarily in the colors/hues of the brown gray scale located directly above the design in the picture above. A few select images in the design will be rendered in full color for visual emphasis.

Schedule

Week 1: Final maquette painting, beginning wall preparation (guidelines mapped out on wall.)

Week 2: Wall preparation: tape, prime, grid, draw, seal

Week 3: Underpainting

Weeks 4-8: Final rendering.

- Tarp

- 2" masking tape

- Paint brushes
