Declaration of Local State of Emergency

Pursuant to the authority vested in the office of the Mayor by the Illinois Municipal Code Section 5/11-1-6, the Illinois Emergency Management Agency Act Section 3305/11 and Ordinance Sec. 7-35.2 of the City of Peoria, I, Rita Ali, the Mayor of the City of Peoria do hereby declare that a Local State of Emergency exists as of this date, Tuesday, October 11, 2022, and shall continue until such time as provided in Ordinance Sec. 7-35.2, the first regular meeting of the City Council on October 25, 2022 or a duly called and noticed special City Council meeting prior to October 25, 2022.

In late 2019 a new and significant outbreak of Coronavirus Disease 2019 (COVID-19) occurred. COVID-19 is a novel virus that can cause severe acute respiratory illness that can spread among people and present symptoms similar to influenza. As of September 28, 2022, the CDC Community level for Peoria is “Medium” and the Illinois Department of Public Health reports 12.4/100,000 for a case rate, 25% of ICU beds available, 2 confirmed Covid-19 diagnosed hospital admission and 1 weekly death. The Governor has issued a Declaration of Emergency that is currently in place through October 15, 2022, given the transmission of COVID-19 throughout Illinois.

During the existence of the Local State of Emergency, the Mayor shall execute such orders which are imminently necessary for the protection of life as provided under the Illinois Municipal Code, the Illinois Emergency Management Agency Act and Ordinance Sec. 7-35.2, including, but not limited to:

1. Implement COVID protocols for City facilities.
2. Evaluate and create temporary procedures for public board and commission meetings to be conducted remotely in accordance with the Open Meetings Act as in-person meetings are not practical or prudent.
3. Evaluate and implement staffing adjustments, work schedules and alternate working arrangements, where necessary.

This Declaration of Local State of Emergency shall be filed with the City Clerk as soon as practicable.



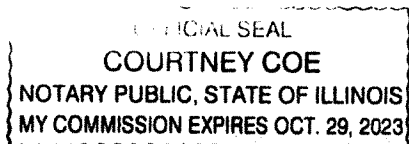
