He described the permitted and special uses for both small-scale and large-scale fulfillment centers as outlined in the Ordinance. He concluded by saying the Ordinance would provide an opportunity for fulfillment centers to be established in Peoria, potentially in existing vacant buildings or spaces.

Council Member Kelly asked Director Black how fulfillment centers with multiple buildings would be classified in the Ordinance. Director Black described some examples of building layouts, how they would be classified, and what kind of impact they would have on the community.

He said it was a unique situation from inception because a channelized creek, part of the stormwater system, collapsed under privately-owned property originally owned by Peoria County. He said the delay in approving the item was due to negotiations between contractors, the property owner, and City Staff. Interim Corporation Counsel Chrissie Peterson confirmed that a two-thirds majority vote was required to adopt the Ordinance.

### **NEW BUSINESS**

### **Commission Reports to City Council**

Council Member Kelly asked about the reporting requirements for City Commissions. Mayor Ali said all Commissions were required to take minutes, but only some reported to the Council on a regular basis. Council Member Kelly requested an item to discuss the Commission reporting requirements to be added to the July 27, 2021, Regular City Council Meeting.

### June 13, 2021, Journal Star Article – Peoria Most Affordable Mid-Sized City in U.S.

Council Member Cyr said an article on page 3A of the Wednesday, June 16, 2021, edition of the Peoria Journal Star featured Peoria as the topmost affordable mid-sized city in the U.S. He said he was working with Strategic Communications Manager Stacy Peterson to promote the story and others like it, stating he was proud to call Peoria his home.

### **Juneteenth** Events

Council Member Allen thanked the vendors, promoters, planners, and others involved in coordinating the Juneteenth events the previous weekend. He said it made him proud to be a Peorian and he hoped the community would keep up the positive momentum. He said he was looking forward to more community events.

### **Recent Violence**

Council Member Allen referenced recent violence in the City and asked for a focus on positive solutions and for help to create a safer community for all citizens.

### **City Staff at Community Events**

Council Member Jackson said the Peoria Fire Department set up a recruitment and information table at an event over the weekend, wherein they received positive community feedback and potential recruits. She expressed an interest in City Staff attending more community events to encourage communication and promote City services with citizens.

### **Community Clean-up Efforts**

Council Member Jackson talked about the success of Community Clean-up events in the First District, but described the growing concern of dumping on public property and rights-of-way that quickly reintroduced health, safety, and infrastructure concerns. She described examples, quantities, and circumstances of items being dumped, as well as potential infrastructure deficiency solutions using American Rescue Plan funding. Mayor Ali asked City Manager Urich for a Report Back on dumping issues in the First District.

### **Build Peoria's 2021 Project - Potent Gratitude Park**

Council Member Jackson said the latest community project for Build Peoria was Potent Gratitude Park, expected to be built next to Sovereign Grace Baptist Church, across from Proctor Recreation Center on W. Martin Street in Peoria. She said Hedy Elliot and Bob Woolsey nominated the project, and \$50,000.00 would be invested to create a space for the community to enjoy. She talked about the potential impact the project would have on the neighborhood.

### Peoria Induction into the Vacant Property Leadership Institute (VPLI)

Council Member Riggenbach said the City of Peoria was chosen out of hundreds of applications to be a part of the Vacant Property Leadership Institute (VPLI), a newly established national organization with a focus on vacant and abandoned properties. He discussed the opportunities it would provide for the City, to include training and resources. He commended the Community Development Department for the achievement.

### Gas Station Plan of Operation and Panhandlers Ordinance Update

Council Member Grayeb inquired on progress regarding the Gas Station Plan of Operation Ordinance and the Panhandler Ordinance as discussed in previous Council Meetings. Interim Corporation Counsel Chrissie Peterson said it was determined the City had an existing licensing scheme for some gas station operators, and Staff was working on an amendment to the existing Ordinance. She said it was yet to be determined how to reimplement the licensing process and retrain Staff on the procedures. She said the Council should expect an Ordinance amendment to be presented in the next month.

### Welcome Council Member Kiran Velpula

Council Member Jensen welcomed newly appointed Council Member Kiran Velpula to the Peoria City Council, stating she looked forward to his input and perspective.

### June 1, 2021, Policy Session Report Backs

Council Member Jensen asked City Manager Urich when the Council would receive the Report Backs from the Special Policy Session Meeting held on June 1, 2021, regarding the American Recovery Plan funds. City Manager Urich said the responses and Staff recommendations would be presented to the Council at the July 13, 2021, Regular City Council Meeting.

### **Advisory Committee on Police-Community Relations**

Council Member Allen said there would be a virtual Townhall of the Advisory Committee on Police-Community Relations via ZOOM on Thursday, June 24, 2021, from 6-7 P.M. in order to have a discussion regarding the committee's mission and goals and allow the public to ask questions or offer suggestions.
