During more discussion, Mrs. Simmons said they basically had a one-stop shop for their customers at this location providing household items, groceries, lottery tickets and any other convenient type of needs.

Liquor Investigator Slavens said the Police Dept. did not have any additional comments to add to their site letter. He said again, they were recommending denial to the subject location, which was located approximately within 180 ft. from St. Ann's Church.

Hearing no more comments or questions, Chairman O'Brien called for the motion.

Commissioner Morris moved to recommend <u>approval</u> of the request for a Class C-1 (packaged goods) Liquor License at 2203 SW Jefferson; seconded by Commissioner Winkler.

In response to a question from Commissioner Morris in regard to the required distance relative to a church, Liquor Investigator Slavens reported the Code prohibited an establishment being less than 100 ft.

Dear Commissioners,

A site application has been received from *TNT Tires & Auto, Inc.*, d/b/a TNT Outlet, 2203 SW Jefferson Ave., Peoria, Illinois for a Class C-1 liquor license. Approval of this application would allow the applicant to sell packaged liquor at this location.

Officer Kevin Slavens inspected the site which is located on SW Jefferson Avenue, along a commercial thoroughfare between Cass Street and Tyng Street. This location currently operates as a convenience store which holds a state and local tobacco license. The proposed site neighbors St. Ann's Catholic Church located approximately 180 feet to the southwest and Southside Manor Apartments, an elderly retirement living community, approximately 355 feet to the northwest. There is also nearby single-family residential housing to the north and northwest behind this site in the 900 blocks of Helen Street and Louisa Street.

This proposed site resides in police district 8, which is one of the busier districts in the city. From January 1, 2021 to December 31, 2021 the Peoria Police Department responded to 109,529 police calls for service throughout the city. In police district 8, officers responded to 7,670 police calls for service in this district and a total of 26,570 calls for service in the three adjacent districts (police districts 2, 3 & 4). Officers handled almost 1/3 of all the police calls for service in the City of Peoria in these four police districts alone in 2021. Furthermore, 41% of all "major crime incidents" in the City of Peoria for 2021 occurred in these four police districts. The Peoria Police Department feels that the addition of a liquor store in this specific area of town will only exacerbate the already high call volume in this area of the city and further strain police resources.

The Peoria Police Department does not believe there is an economic need, nor community desire for another liquor store in this part of town. The Peoria Police Department believes that *UFS*, 1800 SW Adams Street and *Western Liquors*, 712 S. Western Avenue, both of which are located between 0.4 miles and 0.8 miles from this proposed site more than adequately serve the community in this area of town for packaged liquor sales. In addition to those two stores, there are also two nearby taverns both located less than ½ mile from this convenience store as well.

The Peoria Police Department has other obvious concerns that the addition of a liquor store in such close proximity to St. Ann's Catholic Church would make this a very unfavorable location for the sale of packaged liquor. Historically, liquor stores have led to an increase in crime, vehicle and foot traffic, noise, litter, and other similar quality of life issues resulting in a general overall decline of a neighborhood.

Additionally, the 61602 and 61605 are the 5<sup>th</sup> and 9<sup>th</sup> poorest zip codes in the state of Illinois (total of 1568) and the addition of a stand-alone liquor store would not be conducive to the city's efforts to develop and maintain this area of town into a stable and viable neighborhood.

Finally, the Peoria Police Department has consistently objected to site approval applications for standalone packaged liquor stores, specifically in areas of town that have struggling and blighted neighborhoods. Site approvals being location specific and not owner specific, have proven extremely difficult to revoke once approved. Accordingly, the Peoria Police Department recommends **denial** of this site approval application.

To Whom It May Concern,

I received a notice the other day that TNT Tire & Auto, INC has applied for a Class C-1 Subclass Liquor License for their property at 2203 SW Jefferson St. I was appreciative to receive such a notification and wish to offer you my reservations about permitting a license for a public business to sell alcohol in such location.

Reservations based on the fact that 61605 needs fewer public places to buy alcohol not more and that our more or less quiet neighborhood does need the potential of additional crime potentially associated around a new liquor store providing beer and wine for off premise consumption.

A concern of increased violent crime based on a recent study from Johns Hopkins Bloomberg School of Public Health's Center on Alcohol Marketing and Youth (CAMY) which looked at the relation of crime and access to alcohol in the City of Baltimore.

It found that "access to liquor stores has a 37 percent greater association with violent crime than access to on-premise outlets" which sell alcohol to be consumed inside an establishment.

Thus. while I respect the owners of TNT and am grateful for their investment in our part of the city. I cannot bring myself to welcome the sale of off site alcohol consumption at that location with the risk of changing up the dynamics of our neighborhood which could risk lives, businesses, and the viability of our parish church too. We cannot risk additional crime and a deteriorating sense of security in our area.
