





Building and Zoning staff from the Community Development Department have reviewed the above listed request. Following is a summary of the results:

- 1. The property is currently zoned PR (Prospect Road Form District). Retail is permitted within this zoning district.
- 2. Staff coordinated and attended a neighborhood meeting on October 23, 2019. Invitations were sent to residents in the surrounding neighborhood. The applicant presented information and answered questions regarding the proposed business. Thirteen members of the public attended. One attendee voiced concerns regarding future business. Other attendees voiced support.
- 3. Tenant space is currently a vacant shell space. Applicant must first submit plans prepared and stamped by a design professional to obtain a building permit.
- 4. All necessary building and trades permits must be obtained prior to work commencing. Mechanical, electrical and plumbing work must be accomplished by licensed and registered contractors in the City of Peoria.
- 5. Work must be completed as illustrated in approved plans and Certificate of Occupancy must be obtained.

The Community Development Department does not object to the requested liquor license contingent upon issuance of a Certificate of Occupancy.

Dear Commissioners,

A site application has been received from *Mezcal & Miel Company*, d/b/a Mezcal & Miel, 3504 N. Prospect Rd., Peoria, Illinois for a Class C-1 and Subclass 6 liquor license. Approval of this application would allow the applicant to sell packaged liquor and have product tastings at this location.

Officer Kevin Slavens inspected this proposed site which is located on Prospect Road at the corner of London Avenue. This site previously operated as *Trefzger's Bakery* from 1953 to 2016. Neighboring businesses include a used car dealership, automotive specialty store, bank, gas station and other retail businesses. The nearest residences to this proposed site are located directly across the street in the 3400 and 3500 blocks of N. Prospect Road. Both nearby residences are approximately 124 feet to south and 131 feet to the west from this site. There are eight other near-by retailers that sell packaged liquor all within a 1.3 mile radius from this proposed site.

The applicant, Ms. Christell Frausto, hosted a neighborhood informational meeting at Washington Gifted School on October 23, 2019. Officer Slavens attended this meeting and listened to Ms. Fausto's business presentation for Mezcal & Miel and her plans for the building at this site. This location previously received site approval for a Class B liquor license by the City of Peoria Liquor Commission on May 6, 2019 for Shelton's on Prospect.

The Peoria Police Department has historically had concerns and voiced opposition regarding convenient sized type liquor stores requesting site approval outside of an established shopping complex. The Peoria Police Department believes that this applicant has done her due diligence and shown concern for the neighborhood through this application process and could be a good business neighbor to others in this area of town along Prospect Road.

Furthermore, the Peoria Police Department does have some apprehensions about the effects a liquor store could have on the continuing efforts to further develop and maintain this area of town into a viable and prosperous neighborhood and believes that a Plan of Operation that addresses the police department's concerns will provide some safeguards and resources to the applicant's business, as well as the neighborhood itself.

Finally, the Peoria Police Department adamantly requests that if site approval is granted, it be contingent upon a *Plan of Operation* between the City of Peoria and the applicant. The Peoria Police Department suggests that this Plan of Operation require the applicant to install and maintain interior and exterior security video cameras in and around the building and abide by the same requirements that establishments that hold a City of Peoria Subclass 1 liquor license, add LED exterior lighting in their parking lot and be required to close for business by 10:00 p.m. for at least the first year of operation.

The Peoria Police Department can recommend approval of this site application, provided that the applicant agrees to the listed stipulations.






