Council Member Jensen said the request for the tax abatement by Foster Waite Properties would not affect the development of the first three floors wherein Northwestern Mutual had planned to locate.

Assistant City Manager agreed with Council Member Jensen and he remarked that the abatement would only be available should Foster Waite Properties complete the fourth floor of the building. He said the incentive would not be offered for the renovation of the first three floors. He said it was the City's intent to create an incentive to complete the project up to and including fourth floor. He remarked that the fourth floor would be intended as commercial tenant space. He said Foster Waite Properties invested a considerable amount of money on purchasing and renovating the first three floors of the building, and he said it was the City's intent to provide an incentive to complete the fourth floor. He said Foster Waite had inquired about utilizing TIF funds to complete the fourth floor. He said Northwestern Mutual planned to move into the space on the first three floors in March 2016 and that the City's Council vote in this matter would not impact them moving in at that time. He said it was purely an incentive to complete the renovation of the building. He said they would have two years to complete the renovation of the fourth floor; however, there were no immediate plans to do so.

Council Member Moore moved to adopt an Ordinance approving the Foster Waite Properties, LLC Redevelopment Agreement; seconded by Council Member Turner.

Council Member Spain said he would support this item, and he asked the Council to do the same. He said it was important to send the right message to the developer and to offer an opportunity to do the project and to finish the final floor. He said this was an example of a project coming together in a positive way.

Council Member Jensen said she would not vote in favor of this item, noting that it was not needed. She said, given the City's financial state, this agreement was not a necessity. She commented that Northwestern Mutual would move into the completed space regardless of whether this agreement was approved. She said there would be three floors that would be full.

# (16-067) PRESENTATION by Patrick Roesler of the SISTER CITY COMMISSION Regarding Youth Travel to Friedrichshafen, Germany, for 2016.

Mr. Patrick Roesler, current president of Friends of Friedrichshafen provided a presentation regarding the 2016 Youth Exchange to Friedrichshafen, Germany. He said the City would be celebrating its 40th anniversary as a Sister City with Friedrichshafen along with celebrating 38 years of youth exchange. He provided an explanation of how the program worked and the benefits the youth received from participating. He said the cost would be approximately \$2,200.00 per person, which was more affordable than most European trips. He said it was his focus to attract youth in the Tri-County area to participate in the program. For more information he recommended visiting www.peoriasistercity.org. He remarked that youth who returned from such a trip had a broader world view, and he expressed his appreciation for the City's support.

Mayor Ardis said this was a very good program wherein alternative years the City of Peoria hosted youth from abroad. He said it was a great opportunity for kids to experience their culture. He expressed his appreciation for the efforts of Mr. Roesler and his wife, and he said he looked forward to seeing them in the near future to present the 40th anniversary trip.

Council Member Spain moved to receive and file the presentation by Patrick Roesler of the Sister City Commission regarding youth travel to Friedrichshafen, Germany, for 2016; seconded by Council Member Grayeb.

# (16-068) Communication from the City Manager with a Request to Approve Updated Guidelines for the City's REVOLVING LOAN FUND.

Assistant City Manager Chris Setti said the City's Senior Development Specialist, Mr. Cesar Suarez, put a lot of time and effort into updating the City's guidelines for its Revolving Loan Fund. He said the City received a \$500,000.00 grant in 1988 to create said fund, wherein the City matched with approximately \$270,000.00. He said the City loaned out approximately 43 different loans, remarking on the various businesses within the City that utilized the program. He noted the guidelines had not been updated since 1988. He said the guidelines have been revised to bring them up to current best practices. He said the City has not been lending as much money since 2011, which put the money in jeopardy with the Economic Development Association (EDA). He said the money provided for the Fund was restricted money, and he said Staff was looking at ways the money could be targeted to meet the intent of the program and to address some of the community goals, especially with minority businesses.

Mr. Setti distributed a handout to all Council that outlined the major proposed changes of the Revolving Loan Fund. He remarked on the creation of an *ad hoc* Loan Review Panel created to advise the City Manager. He said the changes would focus on small and minority businesses. He said the City Council and the EDA would have to approve the guidelines, and he remarked that the EDA had tentatively approved the proposed changes.

Discussions were held regarding the definition of "full-time employee" (FTE) and how that requirement was calculated and the minimum per hour take-home pay. Senior Development Specialist Suarez said the FTE job equaled to 2,080 hours of work per year.

Discussions were held regarding the default rate. Assistant City Manager Setti said if the City's loan went into default, so would the bank's loan. He said this was traditionally considered "Gap" Financing. Historically, he said the City only had six write-offs, noting that half were restaurants. He said Staff was taking the underwriting seriously. Overall, he said the project succeeded more than failed.

Council Member Jensen commented that it was her hope the proposed changes would improve the default rate.

Council Member Riggenbach expressed his appreciation for the efforts of Staff in updating the guidelines. He said this was not to compete with banks and that the City did not want to diminish the entrepreneur spirit.

Council Member Moore remarked on the efforts of Mr. Suarez and his strategy on managing these loans. She said he worked on minority business strategy and she expressed appreciation for the effort of creating a diversified loan committee.

Council Member Grayeb expressed his appreciation for the discussion and comments of other Council Members. He remarked on the importance of diversifying Peoria's economy. He said one of the goals of this Council and previous Councils was to help move Peoria forward to be a world class medical research and healing center. He remarked on Financing Policy – Allowable Borrowers, and he comment on the need to include sexual orientation.

City Manager Urich said sexual orientation would be included in the document. He said unless there was an objection by the City Council, Staff would make the changes for the next City Council meeting for approval.

Council Member Moore moved to approve the updated guidelines for the City's Revolving Loan Fund; seconded by Council Member Ruckriegel.
