AN ORDINANCE AMENDING AN EXISTING SPECIAL USE ORDINANCE NO. 15,185 IN A CLASS C-2 (LARGE SCALE COMMERCIAL) DISTRICT FOR A SHOPPING CENTER TO REPLACE DUMPSTER ENCLOSURES WITH LANDSCAPE PLANTINGS FOR THE PROPERTY IDENTIFIED AS PARCEL IDENTIFICATION NO 14-08-226-025 WITH AN ADDRESS OF 7815 N KNOXVILLE AVENUE, PEORIA, ILLINOIS

WHEREAS, the property herein described is now zoned in a Class C-2 Large Scale Commercial District; and

WHEREAS, said Planning & Zoning Commission has been petitioned to approve an amendment to the existing Special Use for a Shopping Center under the provisions of Section 2.15 of Appendix B, the Permanent Zoning Ordinance, of the City of Peoria; and

WHEREAS, said Planning & Zoning Commission held a public hearing on August 7, 2014, with respect to said petition, which hearing was held pursuant to a notice of the time and place thereof in a newspaper of general circulation in the City of Peoria, not less than fifteen (15) days nor more than thirty (30) days prior to said hearing as required by law.

WHEREAS, said Planning & Zoning Commission has submitted its report of said public hearing and the City Council finds that to permit such use will not adversely affect the character of the neighborhood, and will not unduly burden the public utility facilities in the neighborhood;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS:

<u>Section 1.</u> That an amendment to the existing the Special Use for a Shopping Center is hereby approved for the following described property:

A PART OF THE NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 9 NORTH, RANGE 8 EAST OF THE 4TH PRINCIPAL MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

1) Waiver to allow landscape plantings along the south property line to screen dumpsters in place of garbage enclosures.

<u>Section 2.</u> All provisions of Appendix B, the Zoning Ordinance, of the City of Peoria, with respect to C-2 (Large Scale Commercial) District shall remain applicable to the above-described premises, with exception to the amendment to the Special Use herein permitted.

<u>Section 3.</u> This Ordinance shall be in full force and effect from and after its passage and approval according to law.
