

**RESOLUTION – No. 17-059**

**A CORPORATE RESOLUTION ACCEPTING A GRANT FROM THE ILLINOIS HOUSING DEVELOPMENT AUTHORITY'S ABANDONED RESIDENTIAL PROPERTY MUNICIPAL RELIEF PROGRAM.**

**WHEREAS**, the City of Peoria has been awarded a grant (the "Grant") from the Illinois Housing Development Authority (IHDA) program administrator of the Affordable Housing Trust Fund Home Accessibility Program (the "Program") in the amount of \$144,450.

**WHEREAS**, the City of Peoria will enter into an agreement with IHDA to provide accessibility modifications in accordance with the terms and conditions set forth in the Agreement.

**THEREFORE BE IT RESOLVED**, that the Mayor and City Council of City of Peoria adopt this resolution authorizing the City of Peoria to participate in the Program including but not limited to entering into the Agreement and undertaking the obligations as the Program applicants.

**FURTHER RESOLVED**, City of Peoria shall enter into the Agreement with IHDA wherein IHDA agrees to make the Grant to the City of Peoria, which shall be used by the City of Peoria to assist with the accessibility modifications for low income elderly or disabled residents within the Recipient's area, all in accordance with the terms and conditions set forth in the Agreement.

**FURTHER RESOLVED**, that the Mayor of the Sponsor and the City Clerk of the City of Peoria are hereby authorized and empowered to execute and deliver in the name of or on behalf of the City of Peoria the Agreement and any and all amendments, modifications and supplements thereto, and to execute and deliver such additional documents, instruments and certificates, as may be necessary or desirable for the City of Peoria to perform its obligations under the Agreement.


**FURTHER RESOLVED**, that the Mayor and the City Clerk be and hereby are authorized and directed to take such additional actions, to make further determinations, to pay such costs and to execute and deliver such additional instruments (including any amendments, Agreements or supplements) as he or she deems necessary or appropriate to carry into effect the foregoing resolutions.

**FURTHER RESOLVE**, that the City of Peoria hereby ratifies, authorizes and confirms and approves all documents and instruments executed in connection with the Grant and the Agreement, including those acts taken prior to the date hereof.


