AN ORDINANCE AMENDING THE CITY OF PEORIA 2017 AMENDED ANNUAL BUDGET RELATING TO THE PEORIACORP FUND TO RECOGNIZE THE RECEIPT OF GRANT FUNDS FROM THE CORPORATION FOR NATIONAL AND COMMUNITY SERVICE (CNCS) FOR AMERICORPS FUNDING IN THE AMOUNT OF \$15,000 AND THE DEPARTMENT OF COMMERCE AND ECONOMIC DEVELOPMENT (DCEO) FOR THE APPRENTICESHIP PLUS YOUTH PROGRAM IN THE AMOUNT OF \$60,000 AND THE CORRESPONDING INCREASE IN EXPENDITURES RELATED TO THE GRANTS AS WELL AS THE TRANSFER OF CITY MATCHING FUNDS FROM THE GENERAL FUND TO THE PEORIACORP FUND IN THE AMOUNT OF \$79,000
