Council Member Grayeb expressed concerns about truck driving schools located close to residential areas. He indicated that the Community Development Department had worked on a solution that would protect neighborhoods.

Community Development Director Ross Black indicated that this item was brought forth after a complaint about the truck driving school at Northwoods Mall and trucks parked at the Town and Country Bowling Alley at Gale and Forrest Hill, which was a zoning violation.

Council Member Akeson voiced concerns about the storage of semi-trucks and trailers at the Expo Gardens on Northmoor.

Community Development Director Black and Mayor Ardis responded to Council Member Akeson's question by stating that Expo had truck auctions and was allowed to park semi-trucks on their property.

In response to Council Member Spain's question, Council Member Montelongo explained that a truck driving school was not an appropriate use for the Northwoods Mall, and he said a meeting was held with Northwoods Mall representatives to discuss this matter.

Council Member Riggenbach expressed concerns about the First Reading process along with general concerns regarding the number of truck driving schools in the area, the students involved, and the income source created by the schools.

Mayor Ardis addressed the Council that, per Corporation Counsel's request, the Council should withdraw the current motion, or make a substitute motion to receive and file, and address this issue at a future Council Meeting.

Community Development Director Ross Black responded to Council Member Montelongo's question that currently three locations, Northwoods Mall, Willow Knolls Shopping Center, and Shoppes at Grand Prairie, would qualify for the zoning change with regards to trade schools with heavy equipment/truck operators.

Council Member Johnson moved for a substitute motion to receive and file and to place on the Agenda for the next Regular City Council Meeting on August 26, 2014, the Ordinance Amending

Appendix B, the Zoning Ordinance, of the Code of the City of Peoria relating to Trade Schools with Heavy Equipment/Truck Operators; seconded by Council Member Spain.

Council Member Akeson asked the Community Development Staff to Report Back on the requirements other communities had regarding truck driving schools.

Mayor Ardis stated that this Ordinance would allow the proper zoning classification for trade schools with heavy/equipment/truck operators, but would not indicate a specific location.

In response to Council Member Jensen's question about truck driving schools in industrial districts, Community Development Director Ross Black said he would need to review the number of truck driving schools in the industrial districts.

Council Member Spain stated that he was concerned about signage in reference to the truck driving schools currently in operation.

Community Development Director answered Council Member Montelongo's question that the City would process the text amendment and, until Council reached a decision, a stay in enforcement would occur. He indicated that Truck Driving Schools were not permitted in commercially zoned areas, which allowed the City to enforce zoning violations.

 - A. ADOPT an ORDINANCE Amending APPENDIX B, the Zoning Ordinance Relating to CANNABIS CULTIVATION CENTERS, and
 - B. ADOPT an ORDINANCE Amending APPENDIX C, the Land Development Code Relating to CANNABIS CULTIVATION CENTERS.

Community Development Director Ross Black provided information about the recent Illinois State Law in regards to medical marijuana for municipal purposes and that applications would be granted soon so a zoning requirement would be needed for Cannabis Cultivation Centers. He indicated that local jurisdictions within the State had limited authority in terms of enacting zoning regulations. He continued to state that a Cannabis Cultivation Center use would be classed as Industrial Use in the Peoria Zoning Code.

In response to Council Member Akeson's question, Community Development Director Ross Black indicated that Cannabis Cultivation Centers could be zoned Agricultural.

Council Member Moore asked Director Black what area of the City would be zoned Industrial 1, 2, and 3, which could include a potential Cannabis Cultivation Center.

Community Development Director Ross Black indicated that the area affected by the zoning change would be all current Industrial Areas from the Bartonville Village Limits along the river, through the Warehouse District, not including downtown, then continue past downtown along the river toward the Peoria Heights area. Director Black also stated that the light industrial districts in the Pioneer Park area would qualify for this zoning use.

Council Member Jensen questioned Director Black in regards to the process required by a potential cultivation center once this Ordinance was passed. She further expressed concerns about potential marijuana dispensaries and indicating them as a pharmacy and if the City had a current zoning use for pharmacies. She requested a report back about other municipalities and the guidelines for dispensaries.

In response to Council Member Jensen's question Corporation Counsel Don Leist indicated that the City would be working with the local police agencies to discuss the possession issue.

Council Member Weaver voiced concerns about the addition of Cannabis Cultivation Centers in the City of Peoria. He questioned if the City would gain financially from the Centers and how many people in the area currently participates in medical marijuana use.

Community Development Director Ross Black indicated that the only revenue that the City would obtain would be from property tax.

Council Member Riggenbach questioned Corporation Counsel Leist on the ramification if the City would not pass this Ordinance. In response to his question, Corporation Counsel Leist indicated that the State of Illinois had already passed this legislation and the community had limited jurisdiction over the Cultivation Centers.

Council Member Akeson requested clarification about the ramifications of not passing this Ordinance pertaining to Cannabis Cultivation Centers in the City of Peoria.

Community Development Director Ross Black indicated that the current law would be a denial of home rule unit of power. He stated that this Ordinance would grant a zoning requirement for Cannabis Cultivation Centers and without this Ordinance, a Cultivation Center could still be granted for the Peoria Area per State law.

Council Member Weaver stated he had consulted several doctors pertaining to the use of medical marijuana and indicated his concerns about this matter.

Council Member Spain expressed his concerns about medical marijuana and potential cannabis cultivation centers in the City of Peoria. He asked City Manager Urich about his thoughts on the Cannabis Cultivation Centers and how it would affect Peoria.

City Manager Patrick Urich indicated that the State's deadline for Cannabis Cultivation Centers would be September 8th to 20th. He said the City would take requests on a case by case basis if someone would contact the City in regards to locating a Cannabis Cultivation Center in the City of Peoria.

Council Member Moore moved to adopt an Ordinance amending Appendix B, the Zoning Ordinance Relating to Cannabis Cultivation Centers; seconded by Council Member Johnson.

ORDINANCE NO. 17,130 amending Appendix B, the Zoning Ordinance relating to Cannabis Cultivation Centers was adopted by roll call vote.

Council Member Turner asked Community Development Director Ross Black if crematories would be included in the zoning change. In response to Council Member Turner's question, Community Development Director Black stated that this zoning change would not exclude them.

Council Member Montelongo said he disagreed with the recommended zoning change and how allowing the change would affect the Fourth District.

Mayor Ardis thanked Community Development Director Black and his Staff on the extensive work provided regarding funeral homes in residential areas.

Council Member Grayeb moved to adopt an Ordinance amending Appendix B, the Zoning Ordinance, of the Code of the City of Peoria, with respect to Funeral Homes in residentially zoned districts; seconded by Council Member Jensen.
