

**ORDINANCE 17,639**

**AN ORDINANCE ABATING THE TAX HERETOFORE LEVIED TO PAY PRINCIPAL OF AND INTEREST ON GENERAL OBLIGATION CORPORATE PURPOSE BONDS, OF THE CITY OF PEORIA, PEORIA COUNTY, ILLINOIS 2010 SERIES C & D, 2011 SERIES A & B, 2012 SERIES A & B, 2013 SERIES A, 2014 SERIES A & B, 2015 SERIES B, C & D, 2016 SERIES C, AND SERIES 2018 A AND THE PARTIAL ABATEMENT OF TAXES LEVIED TO PAY PRINCIPAL AND INTEREST ON 2009 SERIES A GENERAL OBLIGATION BONDS IN THE AMOUNT OF \$371,625; THE PARTIAL ABATEMENT OF TAXES LEVIED TO PAY PRINCIPAL AND INTEREST ON 2015 SERIES A GENERAL OBLIGATION BONDS IN THE AMOUNT OF \$2,014,000; THE PARTIAL ABATEMENT OF TAXES LEVIED TO PAY PRINCIPAL AND INTEREST ON 2016 SERIES A GENERAL OBLIGATION BONDS IN THE AMOUNT OF \$247,665; AND THE PARTIAL ABATEMENT OF TAXES LEVIED TO PAY PRINCIPAL AND INTEREST ON 2018 SERIES B GENERAL OBLIGATION BONDS IN THE AMOUNT OF \$590,516.**

WHEREAS, the City Council of the City of Peoria, Peoria County Illinois, has adopted ordinances for the above mentioned bonds providing for the issuance of General Obligation Bonds, of the City of Peoria, Peoria County Illinois, and providing for the levy and collection of a direct annual tax for the payment of the principal of and interest on said bonds; and

WHEREAS, said ordinances were duly published in pamphlet form, as provided by law, and after the effective date of said ordinances, certified copies thereof were filed in the Office of the County Clerk of Peoria County, Illinois, on the stipulated dates; and

WHEREAS, said ordinances did authorize the issuance of General Obligation Bonds, Series 2009 A, 2010 C & D, 2011 A & B, 2012 A, B & C, 2013 A & C, 2014 A & B, 2015 A, B, C & D, 2016 A & C, and 2018 A & B did provide for the levy of a direct annual tax upon all taxable property within the City in and for each of the years covering said bonds, in an amount sufficient to provide the funds to pay the principal of and interest on said bonds when due; and

WHEREAS, the City anticipates receiving funds which can be made available for the purpose of paying interest on and principal of said amount of the General Obligation Bonds, Series 2010 D, 2011 A & B, 2012 A, B & C, 2013 A & C, 2014 B & C, 2015 C & D, 2016 C, and 2018 A & B and it therefore is advisable and necessary to provide for abatement of all of the tax heretofore levied for the year 2018 by all ordinances covering said bonds; and

WHEREAS, The City anticipates receiving funds which can be made available for the purpose of partially paying interest on and principal of the General Obligation Bonds, 2009 Series A in the amount of \$371,625.00; 2015 Series A in the amount of \$2,014,000.00; 2016 Series A in the amount of \$247,665.00; 2018 Series B in the amount of \$590,516.00;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS as follows:

Section 1. It is found and determined that the City Council of the City of Peoria has provided for the levy of a direct annual tax upon all taxable property within the City in and for each of the years covering said bonds in an amount sufficient to provide the funds to pay the principal and interest on said bonds when due. It is further found and determined that the amount will be available from revenue derived from sources other than such tax levy, which sum is hereby appropriated for the purpose of paying such principal and interest.

Section 2. The tax heretofore levied for the year 2018 shall be and the same is hereby abated as directed above.

Section 3. Forthwith, as soon as this ordinance becomes effective, a copy hereof, certified by the Clerk of said City, which certificate shall recite that this ordinance has been passed by the City Council of said City and is in full force and effect, shall be filed with the County Clerk of Peoria County, Illinois, and said ordinance shall constitute authority for the County Clerk for the year 2018 to ascertain the rate percent required to produce the remainder of the tax heretofore levied in said year and to extend the same for collection on the tax books against all of the taxable property situated within said City.

Section 4. This ordinance shall be in full force and effect upon its passage, approval and publication according to law.
