University St., Peoria, Illinois for a Class B, Subclass 1A and Subclass 2 liquor license. #### **Dear Commissioners:**

Building and Zoning staff from the Community Development Department have reviewed the above listed request. The following is a summary of the results:

- The property is currently zoned C-1 (General Commercial) District. A restaurant and bar are permitted within this zoning district.
- 2. Previous use of the building was a restaurant. No change in occupancy is proposed.
- Should alterations be required to the building, all necessary building and trades permits must be obtained prior to work commencing. Mechanical, electrical and plumbing work must be accomplished by licensed and registered contractors in the City of Peoria.
- 4. Any necessary building and trades permits must be obtained prior to work commencing.
- 5. Install required signage for each accessible parking space (Reserved Parking R7-8 and \$350 Fine signs).
- 6. Parking stalls must be striped pursuant to the Unified Development Code Section 8.1 Off-Street Parking and Loading.
- 7. Dumpsters must be screened pursuant to City Code Chapter 13, Sec 13-40.
- 8. All work must adhere to the Illinois Building Codes and Illinois Accessibility Codes.

The Community Development Department does not object to the requested liquor license contingent upon the installation of required signs for accessible parkings spaces, construction of a dumpster enclosure, and the striping of the parking stalls.
