A Special Meeting of the City Council of Peoria, Illinois, was held June 12, 2021, at 9:00 A.M. at City Hall, Council Chambers (Room 400), 419 Fulton Street, Peoria, with Mayor Ali presiding, and with proper notice having been posted.

ROLL CALL

Roll Call showed the following Council Members were present: Allen (electronic attendance), Cyr, Grayeb, Jackson, Jensen, Kelly, Oyler, Riggerbach, Ruckriegel, Mayor Ali – 10. Absent: None.

ELECTRONIC ATTENDANCE

Mayor Ali announced a notice was received by Council Member Allen in accordance with rules established in Ordinance No. 16,142. He said Council Member Allen would be deemed authorized to attend the meeting electronically unless a motion objecting to the member's electronic attendance was made, seconded, and approved by two-thirds of the members of the City Council physically present at the meeting. If no such motion was made and seconded, then the request by Council Member Allen to attend electronically would be deemed approved by the City Council and Council Member Allen would be declared present.

Hearing no objection to the request for an electronic attendance, Council Member Allen was declared present by Mayor Ali.

Mayor Ali requested a moment of silent prayer or reflection and she asked everyone to keep Council Member Ruckriegel and his family in prayer in light of the recent passing of his father, Robert Ruckriegel. She then led the pledge of allegiance.


Council Member Cyr moved to adjourn the Special City Council Meeting; seconded by Council Member Ruckriegel.
