#### NOTICE OF PUBLIC HEARING PROPOSED INCREASE IN SEWER USER FEES FOR THE CITY OF PEORIA

1. Notice is hereby given that the City of Peoria will seek approval from the Peoria City Council to increase the lateral sewer maintenance fee charged to customers in the Peoria Combined and Sanitary Sewer District, as follows:

a. From the initial and current rate of \$0.7623 per 100 cubic feet to \$0.8773 per 100 cubic feet. It will be recommended that this rate increase take effect on May 1, 2016.

b. Further, it will be recommended that the proposed rate of \$0.8773 per 100 cubic feet be increased to \$1.0089 on May 1, 2017.

2. Notice is hereby given that the City of Peoria will seek approval from the Peoria City Council to increase the city-wide sewer rehabilitation fee charged to customers in the Peoria Sanitary Sewer Rehabilitation District, as follows:

a. From the initial and current rate of \$0.5938 per 100 cubic feet to \$0.8016 per 100 cubic feet. It will be recommended that this rate increase take effect on May 1, 2016.

b. Further, it will be recommended that the proposed rate of \$0.8016 per 100 cubic feet be increased to \$1.0822 on May 1, 2017.

3. The proposed fee increases as outlined above will be brought before the Peoria City Council on March 8, 2016. The meeting begins at 6:00 p.m. at Peoria City Hall, Council Chambers, Room 400, 419-Fulton Street, Peoria, Illinois.
