






# CONTEMPORARY ART CENTER KITCHEN LAY OUT

A site application has been received from the Contemporary Art Center of Peoria, d/b/a Contemporary Art Center, 305 SW Water St., Unit 2A, Peoria, for a Class E-1 liquor license. This license would allow the Contemporary Art Center of Peoria to sell liquor for onsite consumption at their events. The art center is a private, not for profit club, which hosts events to support their programs. The approval is limited to the second floor as indicated on the map submitted with the application.

The Contemporary Art Center of Peoria is located along Water St. in the Riverfront Park area. This area is comprised of small businesses, offices, and restaurants. There are nearby restaurants with liquor licenses, along with a tavern, and the River Front museum, which holds a liquor license. The request for an E-1 club license limits the service of liquor to members and their guests only. There is no prior history of liquor being sold at this location and there have been no know police incidents at this location. It does not appear that approval of this site application would be detrimental to the surrounding neighborhood and is appropriate for this site.

The Peoria Police Department has no objections to this site approval request.

Building and Zoning staff from the Community Development Department have reviewed the above listed request. Following is a summary of the results:

- Exiting egress from the space does not comply with the Americans with Disabilities Act (ADA).
- 2. Insufficient restroom facilities for occupancy of 200.
- 3. No elevator recall function.
- 4. Existing kitchen is permitted for warming only. We understand that a full-service kitchen may be planned. Any addition of kitchen space or function will require Building and Fire review and approval.

Since the initial inspection in March, 2014 no contact has been made by the Contemporary Art Center to request a follow up inspection to verify that any of the above listed issues have been resolved,

The Community Development Department recommends <u>denial</u> of the request for a liquor license.
