

COMMENCING AT THE SOUTHEAST CORNER OF LOT 5 IN SAID WOODROW WILSON SUBDIVISION, THENCE NORTH 80°-24'-48" WEST, (BEARINGS BASED ON THE ILLINOIS STATE PLANE COORDINATE SYSTEM, WEST ZONE 1202), ALONG THE SOUTH LINE OF SAID LOT 5 AND THE SOUTH LINE OF SAID LOT 4, 102.04 FEET TO THE POINT OF BEGINNING OF THE TRACT TO BE DESCRIBED: FROM THE POINT OF BEGINNING, THENCE CONTINUING NORTH 66°-24'-48" WEST, ALONG SAID SOUTH LINE OF LOT 4, 9.54 FEET; THENCE NORTH 30°-39'-02" WEST. 67.95 FEET.
