AN ORDINANCE VACATING SEVEN THOUSAND, SIX HUNDRED NINETY-THREE SQUARE FEET (7,693 SQFT OR 0.177 ACRES) OF W ARROWHEAD STREET, ADJACENT TO LOTS 53 & 54, NORTHCREST SUBDIVISION, PEORIA, IL;

WHEREAS, the rights of way more particularly hereinafter described are no longer of value to the public; and

WHEREAS, in the opinion of the City Council of the City of Peoria, the public interest will be served by vacating said rights of way as hereinafter described and shown on <u>Exhibit 1</u>.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA:

<u>Section 1</u>. All of the rights of way described below and shown on the attached vacation plat, Exhibit 1, which Exhibits for greater certainty are made a part of this ordinance, is hereby vacated and closed, with the exception of reservations contained in Section 2 hereof. Said right of way is no longer required for public use, and the public interest will be served by such vacation as is hereinafter provided for.

ALL THAT PART OF THE ARROWHEAD STREET RIGHT OF WAY LYING WEST OF NORTHCREST DRIVE AS SHOWN ON THE FINAL PLAT OF NORTHCREST SUBDIVISION, AS RECORDED IN PLAT BOOK "P", PAGE 94 AT THE PEORIA COUNTY RECORDER'S OFFICE, SAID SUBDIVISION BEING A PART OF THE SOUTHWEST QUARTER OF SECTION THIRTY-ONE (31), TOWNSHIP NINE (9) NORTH, RANGE EIGHT (8) EAST OF THE FOURTH PRINCIPAL MERIDIAN, PEORIA COUNTY, ILLINOIS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 53 IN SAID NORTHCREST SUBDIVISION, THENCE NORTH 90°-00'-00" EAST, (BEARINGS BASED ON AN ASSUMED DATUM), ALONG THE NORTH RIGHT OF WAY LINE OF ARROWHEAD STREET, 123.50 FEET; THENCE IN A NORTHEASTERLY DIRECTION ALONG SAID RIGHT OF WAY LINE, ON A CURVE TO THE LEFT HAVING A RADIUS OF 25.00 FEET FOR AN ARC DISTANCE OF 39.27 FEET, SAID CURVE BEING SUBTENDED BY A CHORD HAVING A BEARING OF NORTH 45°-00'-00" EAST, AND A LENGTH OF 35.36 FEET TO THE WEST RIGHT OF WAY LINE OF NORTHCREST DRIVE; THENCE SOUTH 00°-00'-00" EAST, ALONG SAID WEST RIGHT OF WAY LINE, 100.00 FEET TO THE EAST LINE OF LOT 54 IN SAID NORTHCREST SUBDIVISION; THENCE IN A NORTHWESTERLY DIRECTION, ALONG THE SOUTH RIGHT OF WAY LINE OF ARROWHEAD STREET, ON A CURVE TO THE LEFT HAVING A RADIUS OF 25.00 FEET FOR AN ARC DISTANCE OF 39.27 FEET, SAID CURVE BEING SUBTENDED BY A CHORD HAVING A BEARING OF NORTH 45°-00'-00" WEST, AND A LENGTH OF 35.36 FEET; THENCE SOUTH 90°-00'-00" WEST, ALONG SAID SOUTH RIGHT OF WAY LINE, 123.50 FEET TO THE NORTHWEST CORNER OF SAID LOT 54; THENCE NORTH 00°-00'-00" WEST, ALONG THE WEST LINE OF SAID NORTHCREST SUBDIVISION, 50.00 FEET TO THE POINT OF BEGINNING, SAID TRACT CONTAINING 0.177 ACRE (7,693 SQUARE FEET), MORE OR LESS.

<u>Section 2</u>. The City of Peoria hereby reserves unto all public utility companies presently operating in, upon, over and under said rights of way, all rights and privileges heretofore granted by City ordinances, including but not limited to, rights under franchises and agreements, which said rights and privileges shall continue in full force and effect the same as if this Ordinance otherwise vacating said rights of way had not been adopted and passed; such rights and privileges with respect to said public utility companies are to remain in effect until, and to terminate upon, the abandonment or release of such use or the relocation of such use outside the public rights of way herein vacated.

It is further provided that no building or other structures shall be erected on the said rights of way herein set forth, or other said reservations be made of such area which would interfere with use, maintenance, renewal or reconstruction of the facilities of said public utilities until such time that all said utilities are terminated as described above.

<u>Section 3</u>. This Ordinance shall take effect and be enforced from and after its passage and approval, subject, however, to the conditions of Section 2 hereof.
