Here are the clarifications to your questions regarding our response to RFP 24—19:

- Budget clarification: The City Council has allocated \$50,000 toward this project. How will this

 The hours and scope of work effort by Prairie Forge Group will be broader and expand with the
 - The hours and scope of work effort by Prairie Forge Group will be broader and expand with the increased budget. The additional hours/time can be spent in several ways: with more detailed designs and planning, in expanding the number of planning ideas, and consideration to paying local college students for their involvement in the effort.
- 2. Student clarification: Please specify or elaborate as to how your firm will recruit and involve a diverse pool of architectural students in this project.
 - 1-Partner with the Judson University Graduate Urbanism Department (professor Daniel Hussey) to design their graduate project around the City of Peoria's Development Corridor areas.
 - 2-Recruit other architectural students from Illinois colleges to photo-document, research, and provide charette/designing ideas for the Development Corridors.
 - 3-Illinois Central College offers an architecture program and a Computer-Aided Mechanical Drafting and Engineering course of studies. We would solicit a partnership/student internship program with the head of the department in the similar manner as noted in #1 above.
 - 4-Recruit college students from the University of Illinois in Urbana-Champaign, which offers an architectural/urban planning program, and apply their skills in the same manner as noted above.
 - 5-Bradley University offers courses in Business, Construction, and Engineering. We would take a similar approach and solicit a partnership with each department having a student internship program.
 - 6-Illinois State University offers courses in marketing. We would seek a similar partnership within their student internship program if marketing skills may be required.

 - We understand the City has partnered with the Illinois Housing Development Authority (IHDA) and has conducted surveys of residents of the South Village.
