

A site application has been received from *Kinuwa US, LLC*, d/b/a Desi Exotic Nation, 816 W. Pioneer Parkway, Peoria, Illinois for a Class B liquor license. Approval of this license would allow the applicant to operate a restaurant with full bar service.

Officer Kevin Slavens inspected the site which is located in a small commercial shopping complex along Pioneer Parkway just west of Knoxville Avenue. Neighboring businesses to this site include a restaurant, small grocery store, salon & day spa, yoga studio and an animal clinic. Officer Slavens also spoke with Mr. Prashant Dave, owner of *Devon Food & Groceries*, 802 W. Pioneer Parkway, who said that he has no issues with a restaurant at this site, but is opposed to the restaurant having a bar. Mr. Dave also resides in the single family residence in the rear of the shopping center behind this site. This residence is on an elevated portion of the commercial property, approximately 43 feet behind the shopping complex. Mr. Dave informed Officer Slavens that he plans to attend the July 1st, 2019 City of Peoria, Liquor Commission Meeting.
