BUDGET REVISION SUBGRANTEE AGREEMENT – COMMUNITY DEVELOPMENT BLOCK GRANT

Pursuant to the Subgrantee Agreement effective <u>February 1, 2020</u> by and between <u>PEORIA CITY/COUNTY HEALTH DEPARTMENT</u> ("SUBGRANTEE"), AND THE CITY OF PEORIA, ILLINOIS, an Illinois unit of local government ("City") for the Community Development Block Grant (CDBG) funds to be utilized for Lead Hazard Control program ("Project"), this Budget Revision is for the 2020 and 2021 program year project funds.

1. GENERAL CONDITIONS.

All other terms, conditions, assurances, certifications and requirements included in the Subgrantee Agreement are not altered by this Budget Revision.

The additional funding for this agreement was approved by City Council as part of the City's 2020 HUD Annual Action Plan (Item # 20-066 on 3/24/2020) and 2021 HUD Annual Action Plan (Item #21-094 on 4/13/2021).

2. TERMS AND CONDITIONS OF THE BUDGET REVISION FOR THE PROJECT.

The Project shall be subject to the following terms and conditions of this Budget Revision:

This Budget Revision commits a total of \$300,000 in CDBG funds as outlined below.

\$150,000	Program Year 2021 CDBG Entitlement Funds	21L00	12

The total costs of a housing unit project shall be divided equally to be paid by the Health Dept. and the City. The maximum amount to be paid by the City is \$12,500 per property unless written permission provided by the City of Peoria. Eligible project costs included property testing, inspections and rehab contractor costs (materials/labor). Project staff time or general administration of this Agreement is not eligible for CDBG fund payment.

The City will require a more detailed budget, project scope and cost for each housing unit to be completed using CDBG funds.

This Budget Revision shall not be altered or amended except in writing signed by the parties hereto.
