PRESENTATIONS

(15-168) PRESENTATION of Findings from the NAACP Following a Review of the City of Peoria's HIRING PRACTICES Over the Past Four Years.

Hearing no objections, Mayor Ardis granted Privilege of the Floor to Mr. Donald Jackson, President of the Peoria Branch NAACP.

Mr. Jackson expressed his appreciation to the City Council for their willingness to address the City's hiring practices. He provided a history of the City's hiring practices, and he said his main focus was on the hiring of personnel in the City's Police Department and Fire Department. He provided statistics of the City's employment of minorities over the past four years, and he remarked on the importance of the NAACP holding government sectors accountable for their hiring practices. He said the NAACP was working with City Manager Urich and Corporation Counsel Leist to devise a protocol to address the issue. He said both the City and the NAACP pledged to continue to work together, and he recommended establishing a timeframe for establishing a protocol. He reviewed Peoria's demographics, and he remarked that the City's hiring practices should simulate the City's demographics. He inquired as to the City's past hiring practices and the status of the Equal Employment Opportunity (EEO) office that used to report directly to the City Manager. He said the NAACP would develop an aggressive plan of action, and he said he hoped the City Council would approve this plan.

Council Member Moore expressed her appreciation for the presentation, and she remarked that this should not only be directed at the City's employment practice, but it should also apply toward the City's hiring of contractors.

City Manager Urich expressed his appreciation to Mr. Jackson for his presentation to the City Council. He said the City was committed in its desire to improve its hiring practices, and he said the Human Resource Department was working on creating a larger pool of candidates for interviews. He remarked that the biggest challenge was getting applicants. He said Corporation Counsel Leist and Mr. Jackson were working on the legal constructs for hiring Police Officers. He said this was an important issue to address, noting that 80% of the minority community throughout the 5-County Metro Area lived within the City of Peoria. He said the City's Human Resource Department would continue to focus their efforts throughout the City to engage more minority businesses.

Mayor Ardis expressed his appreciation to the NAACP. He said he had heard of their willingness to work with the City, and he remarked that the City would continue their efforts to improve its hiring practices. He remarked on the importance of reaching out and educating the City's youth, and he said the City would continue to work with the NAACP.

Council Member Spain expressed his appreciation for the presentation, and he inquired when recommendations would be brought to the City Council for review.

In response to Council Member Spain, City Manager Urich said he anticipated coming back to the City Council with a plan of action within 60-90 days.

Council Member Spain remarked on the importance of including building trades in the plan of action. He said there was a tremendous volume of construction activity, and he said there was a huge opportunity for employment in this area. He said these changes needed to take place and that this needed to be a process for the City to institutionalize. He said Community Construction Outreach was a program that provided private sectors opportunities to utilize the needs of the community, and he remarked on the importance of keeping that program involved.

Council Member Spain moved to receive and file the presentation of findings from the NAACP following a review of the City of Peoria's hiring practices over the past four yours; seconded by Council Member Moore.

Council Member Turner said the City used to have an EEO document that tracked minority hiring in each department, and he inquired whether the City continued to utilize said document. He remarked on the importance of the City Council supporting the City's Administration to address this issue.

Council Member Montelongo expressed a concern for the statistics presented. He said locating potential applicants began with the recruitment process, and he inquired as to what the City utilized to locate and reach out to recruits. He said there were plenty of minority businesses and organizations that provided contracts for local government. He said the resources were available and the City needed to make an effort to utilize them. He recommended including the City's findings in the City's Annual Report.

Council Member Jensen expressed her appreciation to the NAACP for their efforts in this matter and for the presentation to the City Council. She said this was an important issue, and she requested a Report Back on the efforts the City utilized in the last four years to recruit minorities. She said the City needed a more aggressive plan. She expressed a concern on the ratio of male versus female hires, and she said she would support an aggressive plan to address this issue.

In response to Council Member Grayeb's question on whether the City had formalized recruitment efforts, City Manager Urich said those efforts depended on what department was recruiting.

Ms. Debra Bush, Human Resources Coordinator, reported on the City's advertising practices for job openings.

Chief of Police Jerry Mitchell said the Peoria Police Department offered a Police Explorer Program for 14-21 year olds. He said they were looking to extend that program which would eventually lead to testing an employment of the individuals. He remarked on the importance of offering the test more frequently, and he noted it was difficult for an applicant to wait several months for the hiring process to be completed. He said other cities faced the same struggles of hiring minorities as the City of Peoria.

Motion to receive and file the presentation of finding from the NAACP following a review of the City of Peoria's hiring practices over the past four years was approved by roll call vote.

Council Member Akeson remarked on the state of the City's public infrastructure, which was costly to maintain. Due to this expense and the state of the City's budget, she said the City Council should not approve this item, noting the City's need to match the grant.

She said the Council Communication provided an executive summary that indicated the scope of work these properties would need in order to be salvaged, which would cost approximately \$1.3 million to \$1.7 million. She remarked that the money was not available to salvage these properties, and she said it was in the best interest of the City to approve this item.

Council Member Moore moved to approve a contract with River City Demolition, in the amount of \$82,500.00, for the demolition of properties located at 801 NE Perry and 803 NE Perry; seconded by Council Member Turner.

Council Member Akeson said she had requested to defer this matter at the last Regular City Council meeting. She expressed regret that this property had gotten to the point of demolition.

She said, ideally, it would be her desire to preserve the structures until the market turned for the better. She said these structures were a reflection that the City had not been aggressively trying to restore structures. She said she would vote no on this item.

Council Member Riggenbach said this was a regrettable situation, especially for structures that had history tied to them. He said the City Council had previously discussed deconstruction versus demolition, and he asked for the status of the deconstruction process.

Community Development Director Ross Black said the Council expressed an interest to reclaim elements heading towards demolition. In these properties, he said the reality was there was not much left of worth in either structure, and he said that there was nothing left to salvage.

Council Member Riggenbach requested a Report Back on properties that had been deconstructed so the Council could see what kind of steps were being taken.

Council Member Moore said it was not in the best interest of the City to tear down homes to forge a better City. She remarked on the importance of interceding on homes that were in disrepair before they became unsalvageable. She said the City needed to take control of properties in disrepair and develop a program to salvage them before they approached demolition.

Council Member Spain said he was grateful for the earnestness of Council Member Moore and her appreciation and love she had for preservation, and he said he would reluctantly vote against this item.

Council Member Grayeb said the City Council needed to review the City's historic preservation process.

In response to Council Member Grayeb's request for thoughts on what the City could do better in order to prevent historic buildings from demolition, Community Development Director Black said he would appreciate the opportunity to bring back more of a comprehensive answer to that request. He remarked, however, that if every property owner maintained their own property, there would be no need for demolition. He said the City did not have the financial resources to save every property. He said it was key to get to the properties earlier in the process of deterioration. For 801 and 803 Perry, he said at no point in the history of these two buildings was the City the owner of these properties. He said these buildings were solely privately owned, and he said it was the private owners who allowed for the deterioration of these buildings.

Council Member Grayeb remarked on the importance of making historic preservation a priority.

Discussions were held regarding the funds to demolish these properties. Council Member Jensen suggested establishing a revolving loan fund in order to help with historic preservation.

Motion to approve a contract with River City Demolition, in the amount of \$82,500.00, for the demolition of properties located at 801 NE Perry and 803 NE Perry was approved by roll call vote.

Communication from the City Manager with a Request to ADOPT an (15-181)ORDINANCE Amending Chapter 18 of the CODE of the City of Peoria Pertaining to Licensing of MOBILE FOOD VEHICLES. (Refer to Item No. 15-163)

Assistant City Manager Chris Setti distributed a replacement Ordinance to all Council, and then he provided an update on this item. He said the City Council had asked him to split the locations of food trucks into two areas: Downtown and outside of Downtown. He said this item focused on outside the Downtown area. He provided a summary of his findings of the locations for food trucks outside of Downtown. He said there were very minimal spaces across the City, and he reviewed the restrictions that were in place that would prevent a food truck from parking wherever they wanted.

Council Member Montelongo expressed his appreciation to Assistant City Manager Setti for his efforts in this matter.

Discussions were held regarding whether a food truck could locate in District 4 and whether the City Council could zone in that area for food trucks. Discussions were held regarding the licensing of food trucks, noting that the cost would be \$300.00 outside the Downtown area.

Council Member Riggenbach expressed his appreciation to Assistant City Manager Setti for his diligence in this matter. He said the reports provided to the City Council alleviated concerns, and he said he would support this item.

Mayor Ardis expressed his appreciation to Council Member Spain who brought this item to the City Council a few years ago. He also expressed his appreciation to Assistant City Manager Setti for his efforts on this item.

Council Member Riggenbach moved to adopt an Ordinance amending Chapter 18 of the Code of the City of Peoria pertaining to licensing of Mobile Food Vehicles; seconded by Council Member Spain.

ORDINANCE NO. 17,230 was adopted by roll call vote.
