Council Member Kelly expressed a concern regarding the overall cost of this project, noting that the Federal funds received impacted taxpayers. He commented on the potential effect it would have on the current landlords in that neighborhood, the impact it would have on the rental rates, and how it would impact the maintenance of those homes. He said it would worsen the situation on the East Bluff. He said if the Council wanted to improve neighborhoods, there needed to be an incentive for those who already lived in that area.

Council Member Riggenbach said he was in favor of the project, and he commented on the funding streams that were being utilized for this project. He said affordable housing needed to be addressed, which was an issue the City Council had committed to and owed the community. He said he had discussed the project with Peoria Opportunities Foundation and the project was presented to the community several times. He said not approving this item would be a huge disservice to the community.

Council Member Riggenbach moved to approve \$560,077.00 in HUD Home Funds for Peoria Opportunities Foundation for the construction of thirty (30) new, affordable, single-family, owner-occupied homes located in the East Bluff Neighborhood; seconded by Council Member Moore.

Council Member Ruckriegel said the need for affordable housing was real and quantifiable, noting the research that had been conducted by United Way on the issue. He said the City ensured that the new housing mirrored the context of the neighborhood. He said these monies would help stabilize the East Bluff, and he said he would be in favor of the project.

Council Member Moore said she echoed the comments of those Council Members in favor of the item. She commended Peoria Opportunities Foundation for providing decent, affordable housing. She said the City would not have been able to do this project out of its own budget, and she noted this was Federal funding that allowed the City of Peoria to improve its community.

Council Member Ali said she enthusiastically supported this opportunity, noting it was not just an investment in the neighborhood, but was also an investment in people's lives. She said she applauded Peoria Opportunities Foundation, who has been committed to the community for many years. She said she would be voting in favor of this item.

Council Member Jensen said she strongly supported this project. She said the purpose of the HOME Funds was to reinvest in challenged areas of the community, noting that the East Bluff needed investment from the City. She said Peoria Opportunities Foundation was a known entity and had experience with these types of projects. She said she enthusiastically supported this item, noting it was supported by Federal funds and not City funds.

Council Member Grayeb remarked on the need to boost the East Bluff Neighborhood, noting this project would add value to the community. He said he would support this item.

Council Member Kelly said he applauded those who promoted and supported this project, noting their good intentions. However, he asked the Council to consider that good intentions were not a substitute for good economics.

Motion to approve \$560,077.00 in HUD Home Funds for Peoria Opportunities Foundation for the construction of thirty (30) new, affordable, single-family, owner-occupied homes located in the East Bluff Neighborhood was approved by roll call vote.

Council Member Moore said she would be deferring this matter in order to gather additional information as to why the company did not meet the minority and women participation in its bid and why this company requested a waiver for the same. She requested additional information as to how far the City reached out when considering other companies in the City, region or State.

City Manager Urich said the City looked throughout the region for contractors, noting that most of these types of contractors did not reside in the City of Peoria. He said Staff looked within the region to see if there were minority contractors who could provide the service, and he said there were none. He said the Chief Diversity and Inclusion Officer had signed off on the minority clause. He commented that bringing companies from outside the State would increase the cost of the project.

Traffic Engineer Nick Stoffer said Microsurfacing Contractors was the only contractor within the region that did this type of work.

Council Member Moore moved to defer this item to the August 27, 2019, Regular City Council meeting in order to obtain additional information regarding minority and women participation.

Council Member Grayeb commented on the need to address the condition of the streets in the City. He said he was not in favor of deferring this item, noting that the Chief Diversity and Inclusion Officer had already signed the waiver on the minority clause.

Council Member Ali seconded the motion to defer.

Council Member Moore said equal participation in the community was an important issue, noting there needed to be an equitable conversation for those who provided this kind of work. She said it was her hope the Council would agree to get an answer of equitable treatment.

Council Member Montelongo said he supported minority businesses; however, he said since the Chief Diversity and Inclusion Officer said there had been a good faith effort in this process, he would have to support the item. He remarked on the importance of completing this project, noting that weather impacted the process. He said he would not support the deferral, but he recommended continuing the investigation going forward.

Discussions were held regarding the agreement and City Manager Urich said it would reimburse Peoria Public Schools for the Police Officers' time, noting it was only three (3) Peoria Police Officers.

Regarding the number of Police Officers, Corporation Counsel Don Leist said no amendment to the item was needed because it did not change the number of Police Officers in the content of the previous agreement.

Discussions were held regarding Peoria Public Schools having the capability of hiring their own Officers, and it was noted that the Security Officers currently employed in the schools could not be armed. Assistant Chief of Police Michael Mushinski commented on the value of having Peoria Police Officers in the schools in order to establish a rapport with the students.

Council Member Jensen expressed a concern in the lack of manpower in the City's Police Force, especially as it related to the East Bluff. She remarked on the need to have the State Legislators change the law so Peoria Public Schools could employ their own Officers so the City could utilize their own Police Officers for City issues.

Council Member Grayeb commented that Senator Koehler was working on changing the current law so Peoria Public Schools could have armed Resource Officers. He said until that legislation was changed, the City had an obligation to ensure the children and staff were safe.

Council Member Grayeb moved to approve Amendment No. 3 to the Intergovernmental Agreement between the City of Peoria and Peoria Public Schools for the City to provide a total of four (4) Peoria Police Officers to certain specific district high schools; seconded by Council Member Riggenbach.

Council Member Ruckriegel said the Council would like to see the law changed in order to enable school staff to do what they needed to do to protect their students. He said he was in favor of the City assisting in protecting the students until the law was changed, and he said he would support this item.

Motion to approve Amendment No. 3 to the Intergovernmental Agreement between the City of Peoria and Peoria Public Schools for the City to provide a total of four (4) Peoria Police Officers to certain specific district high schools was approved by roll call vote.
