A Regular Meeting of the Joint City Council and Town Board of Trustees of Peoria, Illinois, was held February 9, 2021, at 6:00 P.M. at City Hall, Council Chambers (Room 400), 419 Fulton Street, with Mayor Ardis presiding, and with proper notice having been posted.

### **ROLL CALL**

### **COVID-19 PUBLIC NOTICE**

In accordance with Governor JB Pritzker's Executive Order 2020-69 as amended and extended, limiting meetings to the lesser of 25 persons or 25% of the overall room capacity; and Executive Order 2020-07, as amended and extended, requiring the provision of video, audio or telephonic access to meetings; as well as the CDC recommending social distancing of at least 6 feet between persons, City Hall is implementing changes and restrictions for the City Council Meeting on February 9, 2021, while complying with the spirit of the Open Meetings Act.

Community Development Director Ross Black reviewed the item stating it was a request from City Staff to enter into an agreement with Teska who have previously serviced TIF Districts for the City of Peoria and other communities in Illinois. He reviewed the areas outlined for a potential TIF, noting it had been undeveloped for a decade and exhibited many of the elements to qualify for a TIF. He said approval of this item was the first step for an independent third party review of the area to see if it qualified as a TIF. Should it qualify, he said Staff would then move forward with a redevelopment plan and bring that plan back to the City Council in May of 2021 to create a TIF.

Council Member Grayeb said this property had been vacant for quite some time, noting there were people interested in developing that location. He said should Council approve this item, it would only be a review of the property to see if it would qualify for a TIF. He said approving this item would not approve any Special Use nor preclude public input from the surrounding neighborhoods. He commented that approving this item would be prudent, noting there were issues associated with the property that he and Mayor Ardis had been working together to resolve, to include traffic issues that would need to be resolved before any development took place.

Council Member Jensen said approving this item was the first step toward establishing a potential TIF; however, she reiterated the need to have meaningful public input prior to presenting a redevelopment plan to the City Council.

Discussions were held regarding the possibility of the City entering into an Intergovernmental Agreement with various taxing districts to allow some of those districts to receive a benefit from the TIF.

Council Member Grayeb moved to approve and enter into a contract with Teska Associates, Inc., in an amount not to exceed \$24,450.00 for Tax Increment Financing (TIF) Services for properties generally bounded by North University Street, West War Memorial Drive, West Florence Avenue, and North Parish Avenue; seconded b Council Member Ali.
