**BACKGROUND:** Ricardo and Jesus Martinez, Owners, presented a Site Application for a Class B (restaurant, 50% food) Liquor License for 1621 N. Knoxville Ave. The Liquor Commission voted unanimously to recommend Approval of this Site Application with the restriction of the sale of alcohol for On-Site Consumption Only without the authority to sell packaged alcoholic liquors for Off-Site Consumption.
