Communication from the City Manager and the Chief Innovation Officer with a Request to APPROVE a SOLE SOURCE CONTRACT with URBAN3, LLC. for ECONOMIC ANALYSIS and DATA VISUALIZATION SERVICES, in the Amount Not-to-Exceed \$27,400.00, to Include an Economic Analysis and a Comparative Value Per Acre Model.

# BACKGROUND:

The City of Peoria Innovation Team (i-team) is beginning the research and data analysis process within the selected priority area of neighborhood-scale economic development. Urban3, LLC is a leader in economic analytics of land use and provides unique analytics services evaluating relative economic potency of land uses. This evaluation will be used to inform both overall and geographically-targeted strategies and policy recommendations for neighborhood-scale economic development.

**FINANCIAL IMPACT:** Funding for this purchase would come from the Bloomberg Philanthropies Innovation Grant and is a budgeted item within the 2016 Innovation Team Budget (City Manager's Office).
