Communication from the City Manager and Corporation Counsel regarding the SITE APPLICATION for a Class C (Packaged Goods) Liquor License for the Retail Sale of Alcohol at M and J USA PROPERTY, LLC, D/B/A KING ZONE, 2411 N. BACKGROUND: Muhdi Issa, Owner, M and J Usa Property, LLC, and Godwin Techie, Manager, presented a Site Application for a Class C (Packaged Goods) Liquor License at 2411 N. Knoxville. The Liquor Commission voted 3-0 to recommend <u>denial</u> of this Site Application. Minutes of the December 7, 2020 Liquor Commission Meeting are attached.
