Communication from the City Manager and Emergency Communications Manager with a Request to Authorize the City Manager to Sign a Three-Year AGREEMENT with SUPREME RADIO COMMUNICATIONS, INC. for Electronic Services, in the Yearly Amount of \$123,577.80

**BACKGROUND:** The City of Peoria closed its Electronic Shop on December 31, 2011 and Supreme Radio Communication was contracted to provide services and is currently under contract. Supreme Radio has agreed to continue to provide electronic services at a reduced rate over their last contract for an additional three-year period. Supreme Radio provides electronic services for radio base stations, mobile and portable radios and most electronic equipment for Police, Fire, and Public Works vehicles. They also provide maintenance for the Peoria Fire Department's fire station alerting system.

**FINANCIAL IMPACT:** Funding for this contract will be provided from the current operating budget of the Emergency Communications Center, 1011812-503102.
