Communication from the City Manager, Finance Director, and Community Development Director with a Request to ADOPT an ORDINANCE Amending the CITY OF PEORIA 2021 REVISED ANNUAL BUDGET Relating to the Use of the DOWNTOWN CONSERVATION TIF FUND BALANCE to Erect Safety and Security Fencing Under the MURRAY BAKER BRIDGE in the amount of \$15,000 (Council District 1)

**BACKGROUND:** There are areas under the Murray Baker Bridge within the boundaries of the Downtown Conservation TIF that need to be secured from general pedestrian access. This budget amendment would provide a funding source to fund such projects.
