## **ACTION REQUESTED:**

Communication from the Mayor and Corporation Counsel with a Request to APPROVE the DECLARATION OF LOCAL STATE OF EMERGENCY.

**BACKGROUND:** In late 2019 a new and significant outbreak of Coronavirus Disease 2019 (COVID-19) occurred. COVID-19 is a novel virus that can cause severe acute respiratory illness that can spread among people and present symptoms similar to influenza. Despite efforts to contain the disease, as of February 23, 2022 Peoria County has a 4.06% positivity rate and is classified as a "High" level of transmission per the CDC. The Governor has issued a Declaration of Emergency that is currently in place through March 5, 2022 given the transmission of the Omicron variant throughout Illinois.

The Mayor's Declaration of Emergency must be renewed after each regularly or special scheduled council meeting. The Mayor intends to renew the Declaration of Emergency to include the following:

1. Evaluate and create temporary procedures for public board and commission meetings to be conducted remotely in accordance with the Open Meetings Act.
