ACTION REQUESTED:

Communication from the City Manager with a Request to APPROVE the Program Guidelines and Application for VIOLENCE REDUCTION PROGRAMS Funded through the AMERICAN RESCUE PLAN.

BACKGROUND: On July 19th, 2022, the Peoria City Council held a policy session and gave staff direction to request proposals to spend \$700,000 of the City's allocation of American Rescue Plan dollars.

Staff is requesting Council approval of the program guidelines and application that will be used to issue the request for proposals, score the applications and craft the grant agreements.

If approved, the following schedule will be applicable going forward:

As the schedule above indicates, the proposals will come back to Council for final approval on October 11th, 2022. The first year grant period will be from November 1, 2022, to December 31, 2023.
